Jail Killing Day observed

'Anti-liberation forces active to repeat incidents of Aug 15, Nov 3'

Local Government, Rural Development and Cooperatives Minister Zillur Rahman said in Gazipur yesterday that the anti-liberation forces were still active to repeat the incidents of August 15 and November 3 of 1975 in the country, reports BSS.

He said after the assassination of Bangabandhu Sheikh Mujibur Rahman the anti-liberation forces killed four national leaders on November 3 with a design to destroy Awami League and make the country leaderless.

The minister was addressing as the chief guest a discussion on "Jail Killing Day" at Dardaria, the native village of Bangladesh's first Prime Minister Tajuddin Ahmed, who was killed on November 3 along with three other national leaders in the Dhaka Central Jail.

Afser Uddin Ahmed Khan MP presided over the function. Awami League president member Amir Hossain Amu, Akhteruzzaman MP, Ahsan Ullah Master MP, Syed Ashrafur Islam MP, Meher Afroz Chumki MP, and son of late Tajuddin Ahmed, Tanjin Ahmed also spoke on the occasion.

Zillur Rahman said the anti-liberation forces had also tried to destroy the spirit of the Liberation War and undo the achievements of independence and people's aspirations through killing the national leaders and the architect of independent Bangladesh.

Referring to the recent activities of the Leader of the Opposition, Rahman regretted that when the trial of the killers was going on the opposition leader was trying to save them through creating anarchy in the national life.

The Jail Killing Day was observed in Narayanganj. Narayanganj city Awami League held a memorial meeting at Bangabandhu Road.
