Prices of winter vegetables up

PABNA, Nov 7: Prices of winter vegetables have shot up abnormally in the market causing much inconvenience to the fixed income group of people, reports UNB.

Different varieties of seasonal vegetables now-a-days are coming to the market although abundantly but those are beyond the reach of the common people. According to a market report, a cauliflower is now being sold at Tk 50 and a cabbage at Tk 25-30. But the price of potato is declining day by day. The prices of fish are also on rise as its scarcity is acute in the market.

59 Degree examinees expelled in Chandpur

CHANDPUR, Nov 7: Some 59 examinees have been expelled in the district for adopting unfair means in the English examination on Thursday, the first day of the Degree (Pass) examinations under the National University, reports UNB.

Official sources said the highest number of examinees were expelled from Bangabandhu Degree College centre at Kochua. Eight examinees who were expelled from Hajiganj Degree College centre ransacked some halls of the centre after the examination. At least 3 people, including a policeman, were injured in the incident. The unruly examinees also created disturbance just after the examination at Meher Degree College centre at Shaharasti.

Virus fever breaks out in Madaripur

MADARIPUR, Nov 7: Virus fever has broken out in all thanas of Madaripur district a few days ago, reports BSS.

A large number of people, specially the children and women have been attacked with the disease. Almost every day many patients are coming to the outdoor of the hospital for treatment. Talking to this correspondent some patients said that they were experiencing high temperature and pain in their body. The physicians who were on-duty in the outdoor of the hospital could not say about the actual cause of this virus fever.

10 pry school bldgs being built in Rangpur

RANGPUR, Nov 7: Ten primary school buildings are being constructed by the Local Government Engineering Department (LGED) in Rowmari thana under Kurigram district, reports BSS.

According to an official source, the Facilities Department of the Ministry of Education sanctioned Taka 5.7 million for implementation of the project in the current fiscal year. The construction of the school buildings will be completed within next six months.

Drug addicts on rise

JOYPUHAT, Nov 7: The number of drug addicted youths is on rise in the district with the influx of smuggled drugs from India, reports UNB.

Many youths in different parts of the town and urban areas including the sweeper colony, Akkelpur, Tilokpur bazar have become addicted to drugs as the drugs are being sold in those areas openly.

Jessore Board employee terminated

JESSORE, Nov 7: One employee of Jessore Education Board has been terminated from the service on charge of certificate forgery and corruption. The punishment against 16 others of the board taken earlier by the authorities on the same charge, remained unchanged. The decision was taken in a meeting of the committee of board held on Thursday.

According to a board source, certificate writer Ahsan Habib Mukul, has been dismissed due to his direct involvement in certificate forgery. Three other upper division (UD) assistants of the board including Ansar Ali, Abdullah-Al-Mukit and Mujibul Haque who were allegedly involved in such offence are yet to be punished.

Besides, decision of the board committee taken earlier about 13 other employees, involved in such unfair deal, is yet to be implemented.

No decision was taken about those against whom, several allegations were reported despite threadbare discussion on the subject.

The allegations against them include forgery of certificate, tampering of stock register and illegal promotions.

147 Returning Officers appointed in 6 S-dists

BARISAL, Nov 7: A total of 147 Returning Officers have been appointed in 38 thanas of six southern districts under Barisal division to conduct the forthcoming Union Parishad (UP) elections scheduled to be held from December 1st to December 24.

According to official sources, 34,05,725 voters including 16,98,140 female voters will exercise their voting rights at 2,932 centres having 7,945 booths in Barisal, Patuakhali, Barguna, Bhola, Perupur and Jhalakati districts under this division.

So far 2,932 Presiding Officers and 7,947 assistant presiding officers including 15,893 polling officers will be appointed soon to conduct the election.

SATKHIRA, Nov 7: One housewife was awarded life term imprisonment with a fine of Taka 5000, in default to suffer one year more rigorous imprisonment (RI) for killing her husband.

The convict is Safura Khatun, 25, wife of Shaiful Islam of village Raita under Kalaroa thana of the district.

The prosecution story in brief is that the accused, Safura Khatun with the help of her lover Abdul Khaleque of Munshipara under Satkhira pourasava strangled her husband Shaiful Islam death near at village Nabatkati under the sadar thana on December 21, 1994.

A case was lodged with Satkhira Police Station. Later police after investigation submitted chargesheet against Safura Khatun and her lover Abdul Khaleque.

After examining the witnesses Additional Sessions and Special Tribunal Judge Sheikh Rawnakul Islam awarded the punishment. However lower Abdul Khaleque was acquitted as charged framed against him was not proved.

Child drowns in pond

A three-year-old female child drowned in a pond here at village Tentulia under Kaliganj thana recently.

The victim, Ayesha Khatun, 3, daughter of Amir Gazi while playing by the side of the pond, all on a sudden, she slipped and fell into the pond and drowned. The villagers rescued the body from the pond.

Smuggler gets 2-yr RI

One Person has been sentenced to suffer rigorous imprisonment (RI) for two years with a fine of Taka 500, in default to suffer one month's RI on charge of smuggling.

The convict is Jamal Uddin Sardar of village Shahpur under Kalaroa thana of the district.

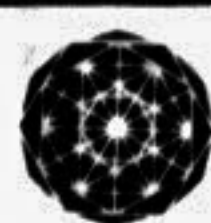
