Teesta Barrage project on verge of closure as water flow falls

NATORE, Nov 23: The unusual fall in water flow at the upstream has brought the Teesta Barrage Project, the largest irrigation project of the country's northern region, to the verge of closure, reports UNB.

Sources at the Water Development Board (WDB) said water flow near the barrage point was recorded between 6000 and 7000 cusec during the first fortnight of November 1996.

But the flow virtually came down to 2,500 cusec during the same period this year. They said all the rivers and tributaries in northern region have marked a drastic fall two months before the beginning of normal lean period, threatening environment as well as irrigation projects there.

"Such fall in water level is normally noticed during the period from early December to January, but this year the water level started falling since early October," said a WDB official.

He continued: This has posed a serious threat to irrigation, riverine transports and fish-

eries as the dry season is approaching when farmers of the region depend on both surface and underground water for cultivation of Irri and Boro crops.

Meanwhile, due to drastic fall in water level of Teesta, Teestamukh Ghat has been declared abandoned and a new ghat, "Balashi ghat", opened for railway ferry services.

If the present trend continues nearly 30 ghats along Teesta will have to be abandoned by December next.

According to a competent source at the Chilmari Inland Port, the alarming fall in water level in the river Brahmaputra has threatened the floating oil depot at the Chilmari Ghat.

The depot supplies fuel to Rangpur, Kurigram, Dinajpur, Lalmonirhat, Nilphamari and Gaibandha districts.

Besides, the water level in rivers Padma, Teesta and Brahmaputra and their tributaries like Atrai, Baral, Barnoi, Dharala, Mahananda, Korotowa and Ghagot are also falling sharply long before the start of the dry season.

Property worth Tk 20 lakh gutted

FARIDPUR, Nov 23: Fourteen families were rendered homeless in a devastating fire that broke out in Gobindapur village under Nagarkanda thana on November 12.

According to local sources, the fire originating from a kitchen, engulfed 19 hometsteads and 8 thatched houses burning away all the commodities within the houses.

Besides, two cattle shed were burnt to death. The loss in the fire was estimated at Taka 20 lakh.

Sirajganj BCL leader stabbed to death

SIRAJGANJ, Nov 23: A pro-Awami League Chhatra League leader was killed by unknown assailants in the town today, reports UNB.

Witnesses said Nurul Amin Jewel, a leader of BCL district committee, died when some unidentified people stabbed him at about 9 pm.

Jewel, who received injuries in the right side of his neck, was rushed to Sirajganj General Hospital where the attending doctors declared him dead. A case was filed.

50 hurt in clash in Narsingdi

NARSINGDI, Nov 23: At least 50 people were injured during a clash in Bhargartek village of Shibpur thana of the district on Wednesday.

According to witnesses, the incident occurred when a gang of about nine people robbed Tk 2.5 lakh from a man identified as Abdul Motaleb near Shristigarh. The armed dacoits stopped the richshaw on which Motaleb was travelling. He was heading for Narayanganj to buy goods for his shop in Kutirbazar.

The dacoits sprayed chilly powder in Motaleb's eyes and then stabbed him.

Two bags of money were snatched from Motaleb's possession, containing a total of Tk 2.5 lakh.

While fleeing from the area at around 11 am, the dacoits fired six rounds of bullets.

When the news of the robbery spread in Kutirbazar, about 200 people headed for the spot of the incident. The local people mistook them to be the supporters of the dacoits and soon made a counter-attack on them leading to a clash that left 50 people injured on the spot. Some of the injured were admitted to Sibpur thana health complex.

MEHERPUR, Nov 23: A case of rape has been filed in Meherpur Court after one month of the incident, police sources said.

Family sources said that on October 10 one Zafarul, son of Pacha Khan of village Subidpur under sadar thana raped Basona, a student of Class V and daughter of Idris Ali of village Subidpur Khanpara under Kutubpur Union of sadar thana.

The victim at the time of rape shouted for help and neighbours came to her rescue and caught Zafarul red-handed. Later in a village shalish Zafarul was convicted and sentenced to pay a fine of Taka four thousand. Since the money of fine was not given a case against Zafarul was filed in the court of Magistrate, First Class of Meherpur district on November 11 under Women and Children Repression Act.

Meanwhile, the associates of Zafarul have been giving pressure to the guardians of the victim withdraw the case threatening dire consequences.

Motor cyclist shot at

An armed gang of terrorists hijacked a motor cycle in Gangni thana shooting the owner of the motor cycle on November 10.

Family sources said, on November 10 when Janbar Ali, 40, of village Akbarpur under Gangni thana was returning home in the evening he was caught by armed hijackers. They took away the motor cycle and shot at him.

The victim has been admitted in Kushtia General Hospital with bullet wounds. He was later operated upon and a bullet was removed from his left hand.

Old man dies in road mishap

One old man, Didar Bakhs, 65, was killed when he was hit by a motor cycle near Ojalpur

village on Meherpur-Kathuli road recently.

Feroz, 30, driver of the motor cycle also sustained serious injury and was admitted in Meherpur Sadar Hospital. Local people said Didar Bakhs did not move when the motor cycle came nearer to him.

Police sent the body to Meherpur Sadar Hospital morgue for autopsy. A case has been registered with Kotwali police station in this connection.

Pest-attack on trees

Shishu trees planted by Forest Department in different parts of the district have been attacked with unknown pest causing extinction of the trees. Gradually the trees are losing their usual strength and leaves are falling and growth is retarded. Ultimately some of the trees have already died. Officers of Forest Department did not take any measure to save those trees, local people alleged.

Poll campaign in Gangni thana

Nomination papers for UP election in Gangni thana of 9 unions were submitted. After scrutiny nomination for 1 chairman 7 male and six female members have been declared invalid.

It has been reported that 6 persons in Bamundi union submitted nominations for the post of chairman but one nomination paper became invalid. 7 members of male and 6 members of female became invalid from Mamundi, Tetulbaria, Kathuli, Kazipur and Gangni unions.

Meanwhile, election activities have generated enthusiasm and gained momentum as the election date is coming nearer. Candidates are contacting from house to house giving assurance of development activities and seeking blessings from the inmates.
