## UP elections Opposition candidates bag majority seats of Bagmara thana in Rajshahi

RAJSHAHI, Dec 3: The candidates of opposition parties bagged all seats of chairman and most of the member posts in eight Union Parishads (UPs) of Bagmara thana in the district.

Awami League supported candidates stood third and fourth position in most cases.

Out of the eight elected chairmen, three belong to BNP, three from Jatiya Party, one from Jamaat and one independent.

They are Abdul Hamid (BNP) of Zhikra union, Mohammad Ali (JP) of Hamirkutsa union, Rezauul Haque Bachchu (Jamaat) of Maria union, Kamal Huseain (JP) of Jugpara, Abdur Razzak (BNP) of Bhalsaniganj, Abed Alu (Independent) of Sirpur union, Jahangir Alam Sarkar (JP) of Goalkandi union and Rafiqul Islam (BNP) of Bara Behanali union.

Sources said, people including a large number of females and old people cast their respective votes in a peaceful manner.

Elections to the rest eight union parishads of Bagmara thana will be held on Wednesday.

Our Staff Correspondent from Khulna says: Elections in nine out of 10 unions in Bagerhat district were held on Tuesday.

A total of 35 candidates contested for chairman posts. Of these, two are women named Sharifa Begum, 35, and Saeda Mariam Begum, 45, who contested from Khanpur union.

Nine persons contested for 27 woman's reserved seats, while 300 for 81 posts of members from nine unions.

At least five persons were injured in polls violence at Bishnapur union on Tuesday. The injured persons are: Shehar Ali, 40, Mobashsher, 25, Miraj 28, Babul 28, and Selim 25.

All of them were admitted to Bagerhat sadar hospital with bomb injuries, police said.

Our Chuadanga Correspondent says: Election in 28 Union Parishads (UPs) of four thanas of Chuadanga district will start from Thursday and will conclude on December 22 of this month.

In all 120 candidates are contesting for the posts of 28 chairmen, 918 candidates are contesting for the post of 247 general members and 268 female candidates are contesting for the posts of 80 reserves seats for the female candidates. In all five general members and four female members have been elected uncontested.

Of the total unions there are 7 unions in Chuadanga sadar thana, 13 unions in Alamdanga thana, 5 unions in Damurhuda thana and 3 unions in Jibannagar thana.

The total number of voters in these 28 unions are 386510. Out of which 180000 are female. According to Chuadanga district election office there are 71 polling stations having 207 booths in Chuadanga sadar thana, 126 polling stations having 338 booths in Alamdanga thana, 51 polling stations in Damurhuda thana having 137 booths and 30 polling stations having 109 booths in Jibannagar thana.

According to Chuadanga district administration and police administration and election office sources all the 278 polling stations of the four thanas are earmarked as risky and 200 polling stations are most risky.

Union Parishads election at the 6 unions of Alamdanga thana will be held on Thursday and polls at seven unions of the thana will be held on December 8. Election in all the seven union parishads of Chuadanga sadar thana will be held on December 11. Election in five unions of Damurhuda thana will be held on December 10 and election in 3 unions of Jibannagar thana will be held on December 22.

BSS adds: Union Parishad elections began in Narayanganj district on Tuesday amid enthusiasm.

## UP elections Kala-azar claims 19 lives in 16 N-districts

From Our Correspondent According to election control room sources, polling in 40 centres in four union parishads of Narayanganj sadar was held peacefully and smoothly.

The unions are Baktaboli, Alirtek, Kutubpur and Siddhirganj. Polling began at 8 am and continued till 4 pm without any break.

Turn out of voters especially the female were very encouraging.

Union Parishad election in 27 centres of Mujibnagar, Monakhali and Daripar unions in Meherpur sadar thana was held on Tuesday peacefully.

A total of 29,412 voters cast their votes in the election.

PABNA, Dec 3: Kala-azar claimed at least 19 lives and affected 500 others in 16 northern districts during the last two months, official sources here said, reports UNB.

Of the dead, three died in Pabna, two in Natore and 1 each in Rajshahi, Naogaon, Chapainawabganj, Bogra, Joypurhat, Sirajganj, Gaibandha, Kurigram, Rangpur, Nilphamari, Lalmonirhat, Dinajpur, Panchagarh and Tahkurgaon.
