## Arms recovered, 10 arrested


By Staff Corespondent The Detective Branch (DB) of police recovered a number of firearms and arrested ten persons in this connection from city's Motijheel and Shabu-



# CHT peace agreement hailed

Different socio-political and professional organisations continued to hail the governnent for reaching an agreement with the tribal leaders within the purview of the constitution to end decades old insurgency in the hill tracts, report agencies.

Workers Party Friday welcomed the signing of peace agreement on Chittagong Hill

It also opposed the stands of BNP, Jamaat-e-Islami and other rightwing groups about the accord, saying the statements of those parties are highly communal and politically motivated.

The Workers Party gave the reaction after its standing committee meeting with president Amal Sen in the chair.

Workers Party leaders Rashed Khan Menon, Haider Akbar Khan Rono, Bimal Biswas and Nurul Hasan were present in the meeting.

Bangladesh Gano Azadi League, in a statement, said it believes that the far-sighted treaty would tie a permanent bondage of brotherhood among the tribals and Bangalees living in the region and play an important role in the economic development of the country.

"We convey our hearty congratulations to the government led by Prime Minister Sheikh Hasina for signing the historic treaty to resolve the longstanding political and socio-economic problems of the Chittagong Hill Tracts upholding the sovereignty and constitution of the country," S M Nurul Alam advocate and Ali Reza. president and general secretary respectively of the party said.

Nari Mukti Andolon, a women organisation, congratulated both the government and Parbatya Chattagram Jana Sanghati Samity for resolving the hill problems.

Muktijuddho Ganomukti Andolon, in a statement, urged all pro-liberation forces to resist those who are opposing the pact to establish peace in the hill tracts as well as in the country. "These evil quarters are now trying to create anarchy in the country after the signing of the treaty," said the statement of the organ-

isation, issued following a meeting with its joint convenor Dr Mohammad Selim in the

Dakkhin Bangla Jubo Kalyan Samity said those who oppose the treaty, in fact, do not want the country's develop-

Mehendiganj Unnayan Parishad observed that the treaty had ushered in a new era of development and peace in the

Bangladesh Civil Service (BCS), Foreign Affairs Association hailed the landmark peace accord between the government and the PCJSS. The association expressed

the hope that the agreement would bring an end to insurgency that lasted for the last two decades in the Chittagong Hill Districts.



Vice-Chancellor Bangladesh Open University (BOU) Prof M Aminul Islam has welcomed the CHT peace agreement and said it would restore peace and tranquillity in the hill districts.

In a statement on Saturday, the VC said sustainable development in backward areas, particularly the maintenance of resources in the Chittagong Hill Tracts, would not be possible without local initiative.

The statement issued in press release signed by 101 prominent educationists of the country urged upon the patriotic people for effective measures for the cancellation of the

"Grouping the three districts of Chittagong Hill Tracts into a region as underlined in the Accord is a clear violation of our Constitution," the statement said adding that it has virtually turned the area into a separate entity beyond the control of the government of Bangladesh.

The executive powers of the Republic has been curtailed and the administrative discipline has also been breached under the Accord, it added. UNB adds: Two hundred and

one physicians have strongly condemned the "unequal and anti-state" agreement on the Chittagong Hill Tracts which, they said, was signed in the name of peace accord. "Through this agreement, a

parallel government has been established along side the Bangladesh government," they said in a joint statement issued in the capital today (Saturday). "This treaty is against the

interests of people, independence, sovereignty and the Constitution, and just a ploy to split Bangladesh," they said and demanded of the government to scrap the accord immediately.


