

Call for action against absentee teachers at JU

A meeting of the faculty deans and chairpersons of all the departments of Jahangirnagar University (JU) unanimously observed that action should be taken against those teachers who are not regular in taking their classes.

Chaired by the JU Vice Chancellor, Prof. Amirul Islam Chowdhury, deans of the three faculties, director of the institute of the university, and chairpersons of twenty departments were present at the meeting, held at the Senate Hall of the Registrar Building.

"No decision was passed in this regard. And measures to be taken to implement this opinion, however, are yet to be chalked out," one of the Deans who attended the meeting told The Daily Star.

"Regularity of the teachers'

attendance in their classes will be now strictly monitored by the deans through the chairpersons of their respective departments, according to an earlier decision," he added.

The meeting also discussed the ambiguity of the '73 University Act regarding the role of dean and chairperson and stressed measures for streamlining these two offices for restoring accountability of the teachers.

Meanwhile, the departments were advised to complete all ongoing examinations sources said, adding presently first year, second year and final year examinations were being conducted.

The overall academic atmosphere of the university also came under discussion during the meeting.

Alleged killer arrested, one SMG seized

The Detective Branch (DB) of police arrested an alleged professional killer and recovered a sub-machine gun (SMG) with ammunition from Khamarbari under Tejgaon thana in the city early yesterday.

Police said during a twelve-hour operation, a DB team arrested Joyjit Singh alias Kalimoni, an accused in several cases, at about 2 am.

Following a statement of the arrested, police recovered the SMG with a magazine loaded with four rounds of bullets, police added.

Police said Joyjit Singh has his own gang of criminals which has been involved in extortion and killing in the Tejgaon area.

A case was lodged with Tejgaon thana in this regard.

Maid torture Bail petition of SI's wife rejected

Runa, wife of SI Shamim, had been absconding since the incident on December 4. She surrendered before the court and submitted her bail petition yesterday.

Rejecting the bail petition, the Additional Chief Metropolitan Magistrate sent her to jail custody.

Earlier, SI Shamim Ahsan was suspended for his alleged failure in arresting Runa, an accused in the torture case lodged with Motijheel thana under the Women and Children Repression Act 1995.

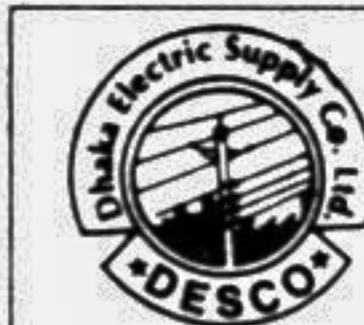
