SC vacation for 80 days

The Appellate Division of the Supreme Court and all courts of the High Court Division will remain closed for 80 days, excluding the government holidays, this year, reports UNB.

The holidays are: January 1 (English new year), January 25, 26 and 28 and February 1, 2 and 3 Eid-ul Fitr and Sri Panchami, April 5, 6 and April 12 to 16 Eid-ul Azha, from August 30 to October 15 annual vacation and from December 13 to 31 winter vacation.

The civil courts will remain closed from December 2 to December 31, said an official handout yesterday.

It said both the divisions of the Supreme Court and civil courts will remain closed during other government holidays, depending on the permission of the Supreme Court.

Meanwhile, the Chief Justice has constituted a vacation bench for hearing and disposal of emergency cases during holidays on January 25, 26 and 28 and from February 1 to Feb 3.

Justice Mahfuzur Rahman will take up the emergency issues from 10:30 am to 1:30 pm on January 28 for hearing and disposal, the handout said.
