Rivers' erosion renders 16,000 homeless

MADARIPUR, Feb 20: Some 16,000 people were rendered homeless in Shibchar thana of the district due to erosion of the rivers Padma and Arial Khan over the last five months, reports

Local people said the homeless people from the erosion-hit areas are pouring in different urban areas for shelter. About 7,500 people have already taken shelter on different parts of Bhanga-Mawa highway. The erosion also threatened some important river ports, market places and other establishments including Shannashirchar and Kawrakandi ferry ghats and Utrail Bandar. The shelterless people who are passing their days in great hardships urged the authority concerned to take steps to rehabilitate them for the sake of humanity.

2 hurt in rivals' clash

NAOGAON, Feb 20: A clash between two rival groups over establishing supremacy at a local Ananda Mela and sharing of gambling money left two people injured and ransacking of a student leader's house on Sunday, reports UNB.

According to witnesses, the incident was a sequel to the trouble ensued between two groups in the mela since its beginning on February 5. Both the groups attacked each other with sharp weapons at 9 pm on Sunday and blasted several cocktails creating panic in the area that left two unidentified visitors injured. Police brought the situation under control. But the angry activists of one group ransacked the house and damaged the furniture owned by local BCL leader Sabbir living near the mela.

According to police, Abul Kashem, 50, of Bara Simla of Kaliganj thana was allegedly killed by his co-villager Mozammel on Sunday while he was going to Kaliganj bazar riding a motor cy-cle. The body was sent to the morgue for autopsy. In another incident a boy, Khokon, 4, was strangulated to death by her mother at village Jethua in Tala thana of the district on Saturday. The mother, identified as Asia Khatun, later allegedly committed suicide by hanging herself. The reason behind the deaths could not be ascertained. An unidentified dead body of a man was found at the verandah of a house at village Durgapur in Assassuni thana on Tuesday. Police suspected that he was murdered by the miscreants following a previous enmity.

Banned fishing nets seized

IRRI-Boro cultivation threatened in 16 N-dists

NATORE, Feb 20: Irrigation in 16 northern districts is seriously being hampered due to drastic fall in water level of Padma, Teesta and their tributaries, endangering the current IRRI-Boro cultivation, reports

A major portion of Chalan Beel in the district is feared to remain uncultivated this sea-

According to Rajshahi divi-sional office of Bangladesh Water Development Board, the water flow in one of the country's largest irrigation project. "Teesta Barrage Project", has reached a record low.

The flow of water of the barrage now stands at 850 cusecs against the last year's flow of 45,000 cusecs.

The entire river bed, both at the up and down streams of the barrage, has been covered with

neumerous shoals. While visiting the project site, the UNB correspondent found that 40 sluice-gates out of 44 of the barrage remained closed. The four gates which remained open, were releasing a

very little quantum of water. Project Chief Engineer Aftab Alam Ansari said the flow of water in the Teesta now stands at its lowest level in last two decades.

He, however, said the matter has been brought to the notice of the authorities of Joint River Commission (JRC) and the ministry concerned. Ansari said a total of 16,000

hectares of land in the northern region had been brought under irrigation network through the project last year. But this year, he said, the ir-

son for lack of irrigation ary rigation target of the project rangements. cause of low flow of water.

Availing the irrigation facilities from the Teesta Barrage last year, the farmers had been able to produce about 50,000 metric tons of additional paddy in the region, he pointed out.

Even though a total of 30,000 hectares of land have been brought under irrigation scheme this season, but the local officials apprehended that the quantum of water in the river would be much lower than our expectation during the peak period of the season (March-April).

Meanwhile, the farmers have become spectical about the supply of fuel in the northern region due to disruption in river communication seems to be caused by the rapid fall in water level of Bramaputra, Jamuna, Baral, Barnoi, Atrai and Hurasagar rivers.

The shortage of fuel has al-

ready become acute in Rangpur, Kurigram, Lalmonirhat, Dinajpur, Panchagarh and Thakurgaon districts following stoppage of supply from the floating oil depots in Balashi and Chilmari ghats.

According to the sources, deplorable road condition in the region has already forced the dealers to transport their fuel supplies from the ghats by boats instead of tank lorries.

Boats were seen to carry fuel to different destinations, including Ulipur, Chilamari, Nageshwari, Bhurungamari, Roumari, Rajibpur, Gaibandha, Sunderganj, Belka, Shobhaganj, Panchpur, Dhupney, Ja-malpur, Mollarhat, Sunderbari and Melandaha areas in Rangpur and Dinajpur districts. In 1997, another floating oil

depot was set up in Balashi ghat, but it still remains inoperative due to fall in water level of the rivers. They said two channels of

Jamuna appear to be closed soon due to abnormal fall in its water level. For which, the river port at Bhaghabari ghat may also face closure.
