Corrigendum Notice

No. 2

In connection with the Notice inviting tender for Tender No. 1/1997-98 vide this Office Memo No. 28/8/30 dated 4.1.98 for 5 (five) groups of works each containing Civil, Sanitary & Water Supply & Electrical works (three discrete portions) of the works of construction of Dhaka Central Jail at Kashimpur under the District of Gazipur. the minister told a seminar on Draft Bill on Human Rights Commission in Bangladesh at National Press Club.

Referring to the composition and mandates of the proposed NHRC, he underlined three points and said the power and function of the Commission will have to be in conformity with the Constitution.

It's mandate should neither overlap nor encroach upon the competence of the judiciary, he said, adding as an advisory body, the Commission should have a mandate embracing protection, promotion and creation of conditions so that every citizen can enjoy the human rights.

The seminar organised by Amnesty International Bangladesh was addressed, among others, by Abbas Faiz of Asia-Pacific Regional Programme, MS Karima Bannoun of Legal and International Organisation Programme, M Zahir and Editor of The Daily Star Mahfuz Anam.

Referring to the Amnesty's advice to supervise the activities of "salish" in rural areas, the Law Minister said that the government has a plan to set up Grameen Court with twin objectives of eliminating the sale of the salish and giving easy and inexpensive protection of law to the rural people.

The Law Minister appeared critical of some NGOs who claim them as champions of human rights and said there should be a credible institution to expose the 'bogus' NGOs which make their fortunes by exploiting the misery of slum dwellers or poor people in rural areas.

Barrister Dr M Zahir told the seminar that the contempt of court law must be amended to allow people scrutinise verdict of the court.

Justice must not be done only, it must be seen to have done, he observed.

Earlier, Mahfuz Anam said if the draft bill on human rights commission is implemented, human rights situation in the country will take a definite step forward.

Referring to the violation of human rights and law, Mahfuz Anam said the present legal system is very slow and cumbersome and people don't feel encouraged to go to court and seek justice.

The Editor said the judicial system must be people-friendly and the judiciary must be made accountable to people.

Shaheed Minar incident condemned

Various organisations have strongly condemned the desecration of Shaheed Minar by a section of unruly youths on Ekushey February and urged the government to take stern action against them, reports BSS.

President and secretary general of the Federation of Bangladesh University Teachers' Association in a joint statement condemned the incident in the presence of Leader of the Opposition and BNP Chairperson Khaleda Zia.

Gaziul Huq and Mustafa Sarwar, president and general secretary of Language Activists and Political Prisoners Council said in a statement that desecration of the Shaheed Minar is tantamount to treason and the culprits should be punished.

Others who condemned the incident are: Bangladesh Mahila Awami League, Ganotantrik Shikkhak Samaj, Dhaka University, Agricultural University, Mymensingh, Bangabandhu Juba Parishad, Muktiuddher Smriti Sangrakshan Kendra, Mahila Muktioddha Sangshad, Centre for Asian Theatre, Jahangirnagar University, ADAB, Bangladesh Chhatra League and Muktioddha Juba Command Kendriyo Committee.

Iranian team meets Satish

The visiting four-member official delegation from Iran called on State Minister for Fisheries and Livestock Satish Chandra Roy at his office yesterday, reports BSS.

The delegation discussed matters of mutual interest. They expressed keen interest for investing in livestock and fisheries sectors, especially in intensive shrimp cultivation and construction of a fishing port.

Ekushey observed in missions abroad

Ekushey February was observed on Saturday in a befitting manner by Bangladesh nationals and mission officials abroad paying rich tributes to the memory of language martyrs, according to reports received here, reports BSS.

National flags were hoisted at half mast atop all Bangladesh missions. Mission staff and expatriate Bangladeshis wearing black badges stood in solemn silence for one minute in memory of the martyrs. They also prayed for the eternal peace of the martyrs.
