About preparations of the operation, Col Farooq said they earlier contacted the Deputy Chief of Army Staff Major General Ziaur Rahman on March 28, 1975. "He told me the seniors have nothing to do. Go ahead if the juniors can," Zia was quoted

as saying. In this regard, Col Rashid

told Maskarenhus that he was the first person to contact Khandaker Mushtaq Ahmed. who became the country's President after the incident. "I asked him (Mushtaq) if he

thinks that the country could run under the leadership of Sheikh Mujibur Rahman. He replied that there is no possibility," the then commanding officer of 2-Field Artillery said. He also told the Grenada

Television that Mushtaq had asked him if there was any possibility of bloodshed. "I replied him 'Yes'. Both Mushtaq and Zia had

emphasised on finding an alternative leadership before going into any operation. Rashid mentioned that he

to my shop in November or December, 1983. He gave me a video cassette and asked to copy it," said Bakhtiar who realised the importance of the video while copying it. He told the court that he also

kept a copy of the video and showed it to some of his friends. He briefly described the text of the interviews. The witness said the CID in-

vestigators on December 2, 1996 came to his friends and seized the cassette with signatures of his two friends Abdus Sattar and Shahriar Hossain. He also signed on it.

"I wrote the names of Col Farooq and Col Rashid on the cassette," he said submitting it to the court.


As the witness was able to describe the text of the interviews, the defence lawyer Khan Saifur Rahman tried to examine his English knowledge and asked him a question in En-
