From Page 1 for International Cooperation of Japan said, "We recognise the need for constructing the barrage but we could only finance the barrage as part of a World

Bank consortium." More than 150 experts on water resource management from home and abroad at the seminar discussed socio-economic and environmental status of the Ganges dependent area and its options for devel-

In the opening presentation of the four part session, the Nepalese Secretary of Water Resources Ministry, Dr Dwarika Dhungel, while sharing his country's experiences, said, "Although Nepal possesses abundant water resources, the level of its utilisation has been minimum. The vision of water resource development as an 'engine of growth' is derived from the fact that this sector has the potential to offer benefits not only to Nepal but also to it's neighbours.

He said, "It has not been possible to utilise seasonal flow of river water because of high costs required to construct diversion structures across the rivers. There are immense prospects for contributing to lean season flow if high dams are constructed."

Held at the International Conference Centre, the seminar was organised by the Ministry of Water Resources in collaboration with WB, ADB and the Japanese government.

Presenting his paper at the seminar, ADB's Senior Project Engineer Jeremy D Bird said. "For a project (Ganges Barrage) of this magnitude it is essential that the first step be such a broad area-based analysis."

He said, "We consider that a study, like that conducted for the north-west region of the country, but with greater linkages to cross-border potential, should be undertaken prior to

Presenting his paper on "Ganges Water Sharing Treaty and the Resulting Opportunity."
Professor Ainun Nishat of Bangladesh University of Engineering and Technology (BUET) said, "Both India and Bangladesh agreed for a solution to increase dry season flows of the Ganges and referred the questions to experts in the Indo-Bangla Joint Rivers

Commission (JRC)." He further added, "There were several proposals from both sides. Bangladesh's proposal was constructing 22 new dams in India and seven in Nepal that would regulate the monsoon flows and provide a dry season flow of 4,600 cubic meter per second, sufficient for both countries. But no consensus emerged on the plan."

He pointed out that "distribution of Ganges flows into the Ganges Dependent Area appears to be the answer. Although a barrage solution would be expensive, it appears to be one of the few feasible economic alternatives to permanently restore flow in the quantities



Police is investigating and DSE authorities have demanded exemplary punishment to them."

At the outset of the meeting, he briefed them on the reforms DSE had made to boost the market. The company executives urged all to work together to overcome the crisis in the capital markets. Replying to a barrage of questions, Noor Uddin said the government has no plan to export gas to India.

He said the demand for gas has been increasing by about 9 per'cent per year. With the present demand rate, the stock of 10.76 trillion cft of gas in the existing 11 gas fields will be exhausted by the year 2020. The Minister said the Sangu

gas will be supplied to northern districts and used to set up power stations at Sirajgonj and Baghabari. If possible, the gas will also be supplied to set up another power station at Naogaon, he added.

Responding to Nazimuddin Alam (BNP-Bhola), Khan told the House that the government has an ambitious plan to de-velop the Shahbazpur gasfield in Bhola. He said that under the plan,

a 20 MW power station will be established in Bhola, a 20 MW station in Gopalganj, 145 MW station in Barisal and 145 MW station in Khulna. Besides, a fertilizer factory will be set up in Bhola

In reply to Abdul Latif Mirza (AL-Sirajganj), the Energy Minister said a plan is under consideration to set up a 300 MW combined cycle power plant at the western side of the Bangabandhu bridge over Jamuna river. Pre-selection of the entrepreneurs are now under pro-

Replying to Srimati Bharati Nandi Sarkar (AL), he said the country's power deficit about 20 to 250 MW. The government has taken certain measures to produce 800 MW of electricity to meet the power shortage.
