Arora arrives Mar 20

Lt Gen (rtd) Jagjit Singh Arora, the Commander of Bangladesh-India Joint Command during the country's Liberation War in 1971, comes here on Friday (March 20) at the invitation of Muktiyuddho Jadugar, reports UNB.

This will be his first visit to the country since General Arora left independent Bangladesh after the occupation Pakistan army, led by Lt Gen A K Niazi, surrendered to the joint command at the historic Race Course Maidan (Suhrawardy Udyan) on December 16, 1971.

General Arora will address a function at the Muktiyuddho Jadugar (Liberation War Museum) on Sunday (March 22) marking its second founding anniversary, said a press release.

During the two years, more than one lakh visitors visited the museum, situated at Segunbagicha in the city.

Arora was the Commander of Eastern Command of Indian Army during the Bangladesh Liberation War.
