The construction of a modern 100-bed Kidney Hospital will begin soon at the Kidney Institute in Sher-e-Bangla Nagar Health Complex, reports UNB.

Arrest of PCP, PGP leaders protested

Different organisations yesterday protested the arrest of the leaders of Pahari Chhatra Parishad (PCP) and Pahari Gana Parishad (PGP) Sanchay Chakma and Dhrubojyoti Chakma respectively on Wednesday.

A combined procession organised by PCP, PGP and Hill Women's Federation (HWF), was brought out in the port city of Chittagong in protest of the arrest yesterday evening.

At a rally following the procession, leaders of the PCP, PGP and HWF condemned the arrest of Sanchay and Dhrubo Chakma. Expressing concern for putting them on remand, the leaders said "the government has shown its fascist face" by arresting the leaders. They also threatened of a stern action if the leaders are not released immediately.

Presided over by Sahadev Chakma, the rally was addressed among others by PGP office secretary Rabishankar Chakma, PCP general secretary Dipayan Khisa, Kang Shai Marma, Uzzal Smriti Chakma and U Chhing Mang Marma.

Meanwhile, National Committee for Protecting Human Rights in the Chittagong Hill Tracts (NCPHRCHT) yesterday condemned the arrest of Sanchay and Dhrubo Chakma, says a press release.
