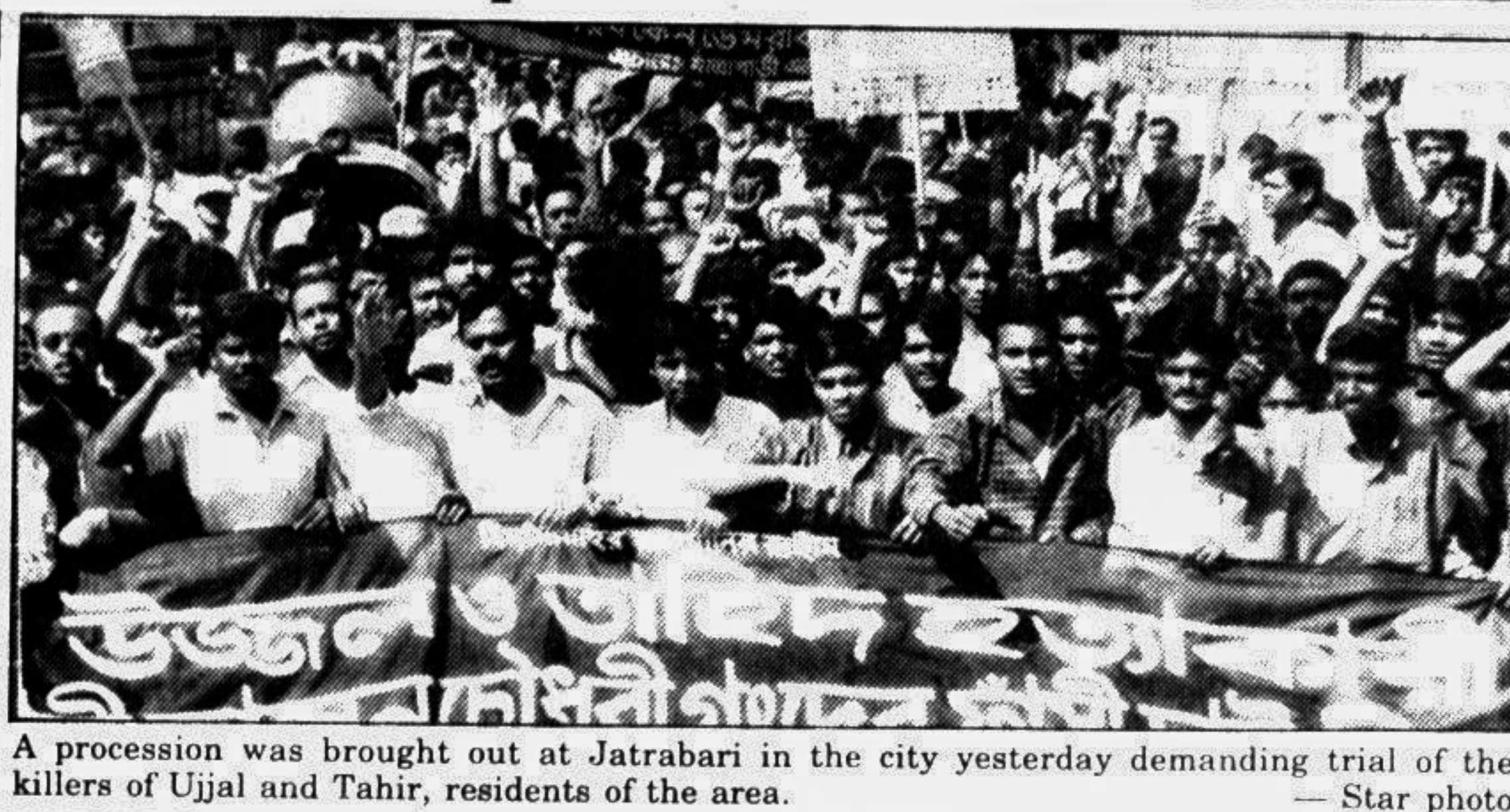

**'No improvement in working condition of garments workers'**

Speakers at an open dialogue on the state of workers in the Garments Sector in the city yesterday observed that in the last ten years, there has been no improvement in the working condition of the workers, over 90 per cent of whom are women.

The open dialogue was jointly organised by the Law Watch and The British Council yesterday.

NGO representatives, lawyers, a representative of the Bangladesh Mukto Garments Workers Federation and a garments factory owner participated in the dialogue held at the British Council Auditorium. There was no BGMEA representative in the dialogue.

Shima Das Shimu of Ubinig, an NGO, said that workers in most garment factories do not have basic facilities like drinking water and toilet. They work in inhuman conditions, she alleged.

Roushan Jahan, a researcher, said that garments factory workers are exploited by the owners but not allowed to do union activities in the factories.

Advocate Fouzia Karim described her experience in dealing in criminal cases filed by garment workers. She alleged that relevant government departments do not show much interest in checking irregularities in garments factories. They give the lame excuse of not having sufficient manpower to check irregularities in sector.

She said, "I get frequent complaints from the workers that they are not allowed their sick leave or maternity leave. There are instances that workers are deprived of wages for months. Allegations of sexual harassment are common but nothing is done to stop such incidents."

General Secretary of the Bangladesh Mukto Garment Workers Federation Lavly Yasmin said, "We get threats from various quarters not to

**Cable operators demand revision of charges**

At least one million viewers across the country are deprived of current international sports programmes as the cable operators have been boycotting the popular sports channel ESPN following dispute with its local distributor over an 'exaggerated fee' of the channel.

Bangladesh Cable Operators Oikya Parishad (BCOOP) started boycotting the channel since January 13 as its local distributor, Translink raised the fee.

The BCOOP at a press conference at its Dhanmondi office yesterday alleged it was still uncertain as to when the local distributor of the channel refused to cooperate despite a series of discussion with them.

"Translink has held us hostage and we will continue boycotting the channel if the charges are not revised," they said.

We were virtually compelled to boycott the channel because from the very beginning they started charging us exorbitant fees compared to other channels and their service in India," said BCOOP Acting Convenor, Saleh Mohammad.

They raised the subscription fee in January from Tk 12000.00 to 23000.00 per year, he added.
