2 killed in separate incidents BENAPOLE: Apr 19: Two people, including an alleged dacoit, received injuries in separate incidents in Sharsha thana on

Friday, reports UNB. Police said Hazrat Ali, 30, a notorious activist of a gang of dacoit, was injured in a bomb blast while making bomb at a residence owned by Abdus Sattar at village Putkhali Obhoybas. Hazrat Ali hails from village Mohinikati in Jhikorgasa thana. In another incident, Ekser Ali, 26, received burn injuries when a gang of miscreants threw acid on him. Police said Ekser, son of Hamizuddin Dhali of village Rajnagar in Sharsha thana, was attacked by the gang when he came out of his house to respond to the call of nature. Separate cases were filed with the police.

#### Dam on Khowai yet to be completed

HABIGANJ. Apr 19: Farmers in Baniachang thana of the district has been apprehending damage of their Boro crops in the coming rainy season as the dam on the river Khowai is yet to be completed, reports UNB.

Water Development Board has started construction of the dam over the river near village Shatamukha of Sujatpur union in the current fiscal year. But the construction remained suspended near the village when a UP chairman objected to the work being done over his crop land. Meanwhile, due to the flash flood of the river Khowai on March 23 caused by incessant downpour and onrush of hilly waters from Tripura, standing Boro crops on 2000 acres of land in Shatamukha, Sujatpur. Ikram, Balla Modhupur and some adjacent villages were damaged. Flood water entered through the suspended portion of the dam causing huge loss to the farmers. Villagers demanded construction of the dam as per the original plan in the area without further delay.

#### Bumper output of potato in 16 N-dists

NAOGAON, Apr 19: A total of 16 northern districts have secured the second position in producing potato in the country

during the current season, reports UNB. According to Agriculture Extension Department (AED). scheme was taken to cultivate potato on 96,8553 hectares of land with a production of about 11.62 lakh metric tons in the northern districts. But exceeding the target a total of 1.12 lakh hectares were cultivation with the production of additional 1.84 lakh metric tons of potato. Despite fog and continuous cold wave the bumper production was achieved, the sources added.

#### Certificate cases filed against farmers

NETRAKONA, Apr 19: Bangladesh Krishi Bank has filed some 5.238 certificate cases against the defaulter farmers in 12 thanas of the Mymensingh district in the current fiscal year. reports UNB.

According to the official sources, about Tk 10 crore have been lying outstanding to the farmers in the district. During the period. Sadar thana branch of the bank filed 697 cases while Muktagachha branch 198 cases, Trishal 157 cases, Fulbaria 101 cases, Gafargaon 287 cases, Valuka 1,347 cases, Gouripur 624 cases, Ishwakganj 158 cases, Nandail 233, Haluaghat 364 and Dhobpura branch filed 230 cases. Meanwhile, only three cases in Sadar branch and two cases in Valuka were settled after payment of the money by the defaulters.

## Pirates attack oil tanker: One killed, 10 hurt

The two seriously injured crew Wahab Ali, 32, and Solaiman, 35, - were admitted to Bhola Hospital.

#### Diarrhoea attacks 1,000 at Savar, Dhamrai

SAVAR, Apr 19: Over 1,000 people were attacked with diarrhoea and other water-borne diseases in Savar and Dhamrai thanas during the last week, reports UNB.

Hospital sources said more than 100 people were given treatment in the thana health complexes.

Doctors attributed the outbreak of diarrhoea to scarcity of safe water and consumption of adulterated food.

Witnesses said local people were seen to take water either from ponds or rivers as they were not getting water from their tube-wells due to abnormal fall in the subsoil water

Local health workers are distributing oral saline in the affected area which was said to be too inadequate to meet the requirement.


## One stabbed to death in Gazipur

Scarcity of quality seeds

# Jute farming likely to be hampered in S-W dists

MAGURA. Apr 19: Jute cultivation is likely to be hampered in the south western districts due to scarcity of High Yielding Varieties (HYV) of jute seeds during the current season, according to jute growers.

Jute growers of Magura, Jhenidah, Narail, Jessore, Khulna, Satkhira, Kushtia, Chuadanga and Meherpur districts are trying to collect jute seeds after preparing their land. But due to non-availability of HYV seeds from the Agriculture Extension Department and BADC, they have to depend on Indian varieties from black markets.

Most of the growers are showing interest to sow smuggled Indian jute seeds in lieu of locally available BADC vari-

eties due to various causes. Farmers do not produce jute seeds locally due to lack of proper initiative of the Agricultural Department. A small number of growers who only produce jute seeds were not able to supply improved quality of seeds this season.

A source of Agriculture Extension Department said, about two lakh one thousand two hundred twenty acres of land were brought under jute cultivation in the south-western districts of the country last year. But many growers did not get good harvest last year due to inferior quality of seeds.

While talking to a group of jute growers including marginal landless they told this correspondent, there was

no marketing facilities of BADC jute seeds. They did not get seeds according to their demand from the BADC offices.

Grabbing the opportunity of jute seeds crisis, smugglers have become active in procuring jute seeds from India. These Indian seeds have flooded rural markets is Magura, Jhenidah, Narail, Jessore, Satkhira, Chuadanga, Kushtia and Meherpur district. Jute seeds are being sold at an exorbitant price in these rural markets. The local jute seeds are being sold at Tk 30 to Tk 40 per kg while smuggled jute seeds at Tk 80 to Tk 100 per kg. According to the market ob-

servers, jute growers are being cheated, buying low quality of jute seeds this season.
