Under the Urban Primary Health Care Project, jointly financed by Government of Bangladesh & Asian Development Bank applications are invited from dynamic persons from the Asian Development Bank member countries to work as Partnership Agreement Consultant (International Consultant) purely on temporary basis. The position is Dhaka-based and 20% of the time may have to be spent in Chittagong, Khulna & Rajshahi City Corporations. The consultant will be a part of a multi-disciplinary team of Project Implementation Unit (PIU) and will have the following responsibilities:

- Meet NGO & other interested groups to obtain suggestion on content of the tender documents and bidding procedure for Partnership Agreement (PA);
- Work with Local Govt. Division (LGD), City Corporations (CC) & Project Director (PD) to establish proper procedures for award of the PA;
- Ensure that bidding & award procedure activities are fairly carried out and that the procedures appear fair & transparent;
- Manage the process of informing private organization potentially interested in bidding for PA's what is involved so that a level playing field is created;
- Help prepare the tendering and bidding documents and ensure that the specifications are written in such a way that they maximize competition;
- Help ensure that the invitations to bid are widely circulated to potential bidders among the NGOs, for profit private sector and provider organizations;
- Respond to questions from NGOs and other interested groups when they are formulating bids;
- Assist the City Corporations and the Partnership Committee in evaluating the bids received;
- Help the City Corporations award the PA's, obtain performance bonds from successful bidders, and ensure smooth inception of the PA's;
- Help establish simple and effective procedures for regular payment of partners;
- Help the City Corporations produce a detailed written report examining the process employed in using PA for services, the results obtained, and recommendations for future CC/LGD policies;
- Help train project management staff and CC staff how PA work and how they need to be managed so that the performance of partner organizations can be effectively monitored regarding compliance with terms of the agreements;
- Ensure that Project and CC staff can successfully manage the PA for the ensuing four years of the project; and
