If yesterday's Engineer's In-stitution function - where the Chancellor and Dr. Iqbal Mahmud shared the same daisis any indication of the former's mood, then it is apparent that she has severe reservations about the former VC. We would strongly urge Sheikh Hasina not to allow hearsay, motivated information and comments like "Dr. Mahmud was a BNP minister" to cloud her mind. It she wants to remember that he was a BNP minister, then she should also remember on what ground he resigned (and she should also remember that more than one of her cabinet ministers were highest level government servants of Gen. Zia's government). The reason we mention it is because these factors should not cloud her mind. The integrity, and honesty of people should be the only consideration in making a judgement in this case. We are surprised and dumbfounded at the education minister's quite unnecessary and provocative reference to Dr. Mahmud being a former BNP minister. Was n't this fact known when he was offerred the post of the VC by this government. If it did not matter then, why should it matter now. We are also disturbed by

what the education minister said about other teachers lining up to fill the post of the VC. The tone and content of his press conference was condescending and insulting to the teachers. We are confused as to why the minister said what he did. Did he want to solve the problem or was he out to vent his anger on the VC and the BUET teachers? It appeared to us like the latter, in which case, he seems to have terribly misjudged the situation. The teachers now consider him to be a part of the problem and not a part of it's solution. They have refused to hold discussions with him. This, on the contrary, we think is to go on to the other extreme. Denigrating an elected minister in such a manner cannot serve the cause of the teachers, just as insulting the teachers in the a manner that he did cannot, and did not, serve the purpose of a government whose intention, we still hope it is, to restore normalcy in BUET. We think the minister should withdraw his remarks and the teachers their decision.

As and when Dr. Mahmud is back in the saddle (we do not say "if" because we do not think there will be any solution without him. Therefore the government will be well advised not to think of an alternative till this problem is solved), he should be allowed all the freedom of action suitable and necessary for a VC. Our understanding is that, just before the problem suddenly went out of hand, every side wanted an amicable solution. This, could not happen because the people concerned did not submit their last letter to the Syndicate or the VC according to what was agreed upon. We have talked to these teachers who said they were not properly informed as to what was wanted of them. We believe that some of the problem was the result of absence of direct communication between the two groups. There were too many intermediaries and too many knee-jerk reactions.

Two things need to be made clear. First, the decisions of the Academic Council and of the Syndicate, in their respective jurisdictions, must not be tempered with. And no amount of political or other pressures should change them. All teachers will have to obey that regardless of the faculty they belong to. Second, the department of Architecture must NOT be treated as an adjunct to the engineering University. They have separate needs and goals. We must adopt the global trend in this discipline. We support the setting up of a separate Institute of Architecture. However as long as the present Architecture faculty exists as a part of BUET it must abide by the University's laws and decisions.

Having talked to all sides it is our view that misunderstanding and lack of communication have added to the problem which, in addition to being of long standing in nature became more complex and acrimonious because of organisational factors and personality clashes not to mention the 'easy' access to the power that be, which gave some people larger than life status. We strongly feel that there should not be any vindictiveness. The 13 Architecture faculty members must be allowed to rejoin their work in BUET. Whatever procedural mistakes and "flouting of BUET laws" they are guilty of will have to be taken account of after they have been reinstated. We understand that the review process permits all that, and Dr Mahmud was quite willing to take that route. but for the arrogant refusal of a section of architecture faculty member to submit review peti tion in the appropriate terms and language. What a reason to put a whole university in chaos.

The initiative now lies in the hands of the Chancellor. We think she was ill advised by those who had 'easy' access to her as to the integrity and intention of the VC, who was harassed and put under tremendous pressure. This ultimately and perhaps unintentionally. ended up as direct interference in the autonomus functioning

of BUET. The Chancellor will give a wise account of herself if she immediately requests Dr. Mahmud, as we had suggested earlier, to resume his duties assuring him of her full and unambiguous support and leaving the solution to his best judgment. We think Dr. Mahmud is wise enough, fair enough and farsighted enough to do justice to all, and do what is best for BUET. We urge all concerned to let their wisdom and not their vanity lead them on this occa-

Compromise on major issues by political parties must

Foreign Minister Abdus Samad Azad yesterday underlined the greater need for accommodation by the political parties on major issues facing the nation and urgency of understanding the democratic values in running the state affairs, reports BSS.

Referring to the prevailing situation in the country the Foreign Minister said, "There must be accommodation and respect for each other's opinions for the smooth running of the state and building confidence among the people for the betterment of the country."

The Foreign Minister was addressing as chief guest at a function marking the Golden Jubilee of Bangladesh Dental Association (BDA).

Presided over by Dr A Hasan, president of BDA, the function was also addressed by Prof M Amanullah, State Minister for Health and Family Welfare Abul Hasan Chowdhury, State Minister for Foreign Affairs and Kamal Bakht MP.

Azad said in addition to the constitutional provision, the Prime Minister also stated time and again that her government will resign prior to polls to hold free and fair election. He said democracy is a culture, which we all must practice for its flourishment.

Referring to the escalation of terrorism in the country, Azad said we have to free the society from this evil stuff. "If we cannot eliminate terrorism, it would finish us all," he cautioned.

The Foreign Minister welcomed the attitude of the opposition to be in Parliament and said there is no alternative but to take part in parliamentary activities for better functioning of democracy. The ruling party must also be prepared to sit in the opposition, he said adding only election will determine which party will occupy posi-

tion or opposition bench. The Foreign Minister said in democracy there would be differences in opinion, a matter which is both natural and expected. He said "what is not desirable is jealousy and hatred," rather "we should stress respect for each other and accommodation of other's opinion."

Azad lauded the role of the dentists in keeping the health of the nation. He said teethes are very vital for digestion of food what keep our body engine fit for work.

The Foreign Minister said because of the dearth of required number of physicians and provision of quality services, a good number of patients travel outside the country for treatment causing huge drainage of scarce foreign exchange. He underlined the need for more qualified doctors and ensuring better medicare facilities to arrest this trend.

Prof Amanullah while emphasising the importance of dentist in ensuring the health of the nation, said the present situation of one dentist per two lakh people is unacceptable. "We must make all-out ef-


