Corruption grips Natore hospital

NATORE, May 15: All sorts of surgical treatment has been stopped at Natore Modern Sadar Hospital for the last one year due to lack of consultants, reports UNB.

The 100-bed hospital started functioning from May 1995 with a view to providing medical facilities to 15 lakh people of the district. But the people are deprived of the facilities due to lack of proper care by the authority concerned.

The eye specialist who is on deputation here is residing in Rajshahi while the dental surgeon of the hospital is working at Rajshahi Medical College Hospital on deputation for the last one year forcing the patients to receive costly treatment at the private clinics.

A consultant for Surgery Department was transferred here on April last year. But after joining his post he went back to Dhaka immediately and no consultant has yet been posted here.

Patients here alleged, most of the doctors are engaged with private practice outside the hospital.

Moreover, doctors refer them to the private pathological laboratories in the town for pathological tests although the hospital has a full-fledged lab, they added.

According to a reliable source, most of the departments lack physicians and manpower. Besides, an ECG machine remained inoperative for the last 10 months since its installation causing problems to the serious patients. There is a blood

bank merely in name but the patients could not get any help from it.

A source, on condition of anonymity, told the hospital is gripped with corruption and irregularities.

Yearly allocation for the hospital is Tk 22 lakh but the amount cannot be used properly for the improvement of medical facilities due to alleged corruption.

It also learnt, the hospital received Tk four crore additional allocation for the year 1996-97, but no significant improvement of treatment facilities could be done with the amount due to alleged malpractice.

Besides, the hospital lacks necessary life saving drugs and some common medicines.

Teesta Project remains a dream for 37 years

BOGRA, May 15: The Bari Teesta Pilot Irrigation Project, an ambitious programme to improve irrigation facilities in Nilphamari district, could not be implemented in 37 years, reports UNB.

According to officials, the project was undertaken in 1960 on a 7934-acre area under Water Development Board to facilitate irrigation to 29,344 acres of land in Dimla, Jaldhaka and Kishoreganj thanas of Nilphamari district.

Under the project, a barrage was built on Bari-Teesta near Kaliganj border of Lalmonirhat district in 1963 and excavation work of its main canal, and construction of 42 culverts were completed in 1983.

But the project was shelved in 1991 as its main canal had been dug wider than its actual plan. The authorities apprehended that the fault might hinder proper supply of water in the area.

Later, a programme had been taken up at a cost of Tk 7.81 crore under System Rehabilitation Project to narrow the canal.

Later, the work on the system rehabilitation project and

rebuilding of some structures had also begun, but the project was suspended again for lack of fund.

The project was supposed to be completed by June this year. Local farmers alleged that they were being deprived of producing paddy worth about Tk 900 crore due to non-implementation of the project and acquisition of land for it.
