## notice on govt organisations

By Staff Correspondent The Bangladesh Environmental Lawyers Association (BELA) has served a legal notice on different government organisations demanding postponement of all activities in the Dhanmondi Lake Development Project because the scheme had no environmental clearance as required by the Environment Conservation Act, 1995, said a

BELA press release. The legal notice was served on the Secretary, Ministry of Housing and Public Works, Mayor, Dhaka City Corporation, Chairman, Rajuk, Director General, Department of En-vironment, Chief Engineer, PWD, Executive Engineer-II, PWD and Vitti Sthapotibrinda

The notice said that the residents were denied a consultation in the designing or implementation of the scheme as required legally and they have no idea what sort of development is taking place.

The notice claimed that such non-observance of legal provisions amount to gross disregard to rule of law and interfering with people's right to enjoy-ment of life and property.

The notice referred to published reports and said that few of the project's components were purely commercial in nature, which, if given effect to, would destroy the residential characteristics of the vicinity.


