Pakshey Bridge work starts by year end

PABNA, May 27: Construction of Pakshey Bridge, the second largest bridge of the country, will be started in the later part of this year at a cost of Tk 595.56 crore, reports UNB.

This was disclosed at a meeting held at the Deputy Commissioner's conference room on Thursday with DC Mahabubur Rahman in the chair.

The meeting discussed about acquisition of land in Pabna and Kushtia for construction of the bridge.

Publication ceremony

NATORE, May 27: A reception was accorded to novelist Safiuddin Sardar. The publication ceremony of two of his novels were also held at Islamic Foundation auditorium on May 16. The novels are 'Biponna Prohor' and 'Shesh Prohor'.

Novel Readers' Forum in Natore organised the ceremony. It was attended by M Ishaq Bhuiyan, DC, Natore as the chief guest. Abdus Sakur, Deputy Director of the foundation was in the chair.

According to official sources, 200 acres of land from both the west and east banks of the river are needed for the 2.15 km long and 18.10 metre wide bridge, of which 83 acres will be acquired in Pabna and the rest in Kushtia.

Of the total amount, Tk 342.70 crore will be provided by the Japanese government while the rest from own resources.

The two governments have signed a note of exchange on March last in this regard, and the final agreement is expected to be signed next month, the meeting informed further.

Executive Engineer of Roads and Highways Department, land acquisition officer AC (Land) of Iswardi thana and officials of PWD were present in the meeting.

The meeting also informed that a 10 km connecting road will be constructed at the eastern side of the bridge while six km at western side of the river Padma.

Meanwhile, two British firms along with a local firm had already completed feasibility study of the bridge in 1996. Other necessary works will be started just after the formal inauguration of the Jamuna Bridge next month for traffic.

Dacoits take away money, valuables

SYLHET, May 27: Armed dacoits looted valuables and money in cash worth about Taka one and a half lakh from the house of Prithi Ranjan Chowdhury at village Burguna in Balaganj thana on Wednesday night.

The houseowner, Prithi Chowdhury, Headmaster of Burguna High School was asleep in his house, on the night of incident. A gang of armed dacoits entered into the house by breaking open the back door of the house at about 1 am. The houseowner woke up and tried to make a shout, but the dacoits prevented and tied up him, his wife and two children. They also gave him a good beating. The dacoits took away gold ornament, money in cash and other valuables at gun point.

While fleeing, the dacoits blasted a number of crackers with a view to creating panic among inmates of the house as well as the villagers.

On getting informations, a police team from Osmaninagar police investigation centre visited the spot, but no case has yet been filed, sources said.

Murder of UP member sparks tension in 2 Kushtia villages

KUSHTIA, May 27: Tension prevails at Jagoti and Chechua villages following the murder of a Union Parishad (UP) member of Jagoti union on Tuesday night, reports UNB.

Looting and ransacking of houses of Jagoti continued till last Friday. Most of the people including the females fled their village for fear of life.

The situation aggravated when both the Liku and Bhola groups chased each other and engaged in looting and arson on Friday.

Fleeing female members of the village were looted by a gang of miscreants at several places. Those who are still in their houses have been passing their days amid insecurity.

The people of adjacent village Chechua also deserted their homes and hearths for fear of life.

Meanwhile, people of Jagoti, have submitted a memorandum to the Deputy Commissioner demanding exemplary punishment to the killers of their UP member Sukur.

Police patrol have been intensified but the activities of terrorists in several areas are reportedly going on unabated.

Six houses, 12 shops gutted

KHULNA, May 27: Four kutcha and two semi-pucca houses were gutted and valuable assets destroyed in a devastating fire at Deben Babu road in ferry ghat area in the metropolitan city here on Sunday, reports UNB.

According to the fire office, the fire originating from electric short circuit in a house at 9 pm soon engulfed the adjacent areas.

The fire servicemen extinguished the fire after 45 minutes of frantic efforts.

Another report from My-mensingh adds: Twelve shops were gutted and valuables worth about Tk 10 lakh destroyed in a devastating fire at Keshoreganj bazar in Fulbaria thana last week.

According to witnesses, the fire originating from electric short circuit in a shop at 9:30 pm soon engulfed adjacent 12 shops on May 16.

Local people with the help of police extinguished the fire after one and a half hours' of frantic efforts.
