**With passing of CHT bills 'Isolated tribals incorporated with core activities of state'**

The speakers at a seminar on 'Peace in Chittagong Hill Tracts' yesterday said the isolated tribals were incorporated with the core activities of the state with the passing of CHT bills in the parliament, reports BSS.

The tribals in CHT remain isolated from the mainstream since the last 1400 years. This is a great achievement of the government of Sheikh Hasina that she has been able to incorporate the tribals for the first time with the central state machinery by signing CHT peace accord within the periphery of the constitution," said noted lawyer Barrister Amirul Islam.

He said the tribals did not bow down to any rule before signing of the CHT peace accord and they were controlled by the Hill Tract Regulation Act of 11900. The CHT was then treated as a specialised zone, he added.

Islam asked Begum Zia to find out and mention any section or clause of the bills which is contrary to the Constitution. Organised by Samaj Badal, a social organisation, the seminar was also addressed among others by M R Akhter Mukul, journalist Santosh Gupta, Ganotantrik Karmi Shibir leader Comrade Nurul Huj Mehedi and Awami League MP Nurul Islam Nahid. Acting editor of Daily Ittefaq Rahat Khan presided over the function.

M R Akhter Mukul said the government of Sheikh Hasina has signed CHT accord at a time when the ethnic problems in different countries of the world have taken a serious turn.

Describing the CHT peace accord as the second great achievement of the government after Ganges water sharing treaty he said a vested quarter who are involved in arms trafficking and smuggling has taken a stand against the landmark peace accord.

Santosh Gupta criticised the opposition BNP for their call to join in the long march with arms and said a peace loving political party cannot utter such a word which may lead to a destructive activities in the country.

Nurul Islam Nahid said the peace accord was done as a follow up of the initiative of former president Ershad and prime minister Begum Khaleda Zia. But, unfortunately BNP started opposing the Awami League government negotiated peace talks from the very beginning, he regretted.

He said BNP remained absent in the national committee on CHT and during discussion on CHT bills in the parliament in planned way with an intention to create anarchic situation in the country.

**SC Bar Assoc team meets PM**

The newly-elected office bearers of the Supreme Court Bar Association led by its president Habibur Islam Bhuiyan called on Prime Minister Sheikh Hasina at Ganobhaban yesterday, reports BSS.

They congratulated the Prime Minister for appointing some new judges.

Sheikh Hasina said her government has taken steps to improve the judicial system and update laws. She said a drafting division has been set up which will draft laws relating to various subjects.
