



snatched from businessman NARAYANGANJ, June 13:

Four armed motor cyclists snatched away Taka 2 lakh 50 thousand from a business man in a broadday light dacoity at Punabo on Kanchan Bolta road under Rupganj police station this morning, reports BSS.

According to police sources, the businessman Alfazuddin. 50 alongwith his two sons and a friend were coming to Narayanganj from Kanchan bazar by a private car at about 10:30 am.

Their car came under attack by the armed daçoits who were riding motorcycles. They dragged down Alfazuddin from the car and snatched away Taka 2 lakh 50 thousand from his possession at pistol point and fled away, police said.

None was arrested in this case so far. A case was registered with Rupganj Police Station.


