



Jatiya Sangsad yesterday began general discussion on the proposed national budget for 1998-99 fiscal.

The main opposition BNP is yet to join the budget session which began on Wednesday. Finance Minister SAMS Kibria placed the budget in par-

liament on Thursday. Five Treasury Bench members took part in yesterday's general discussion. They thanked the finance minister for presenting 'a pro-people budget'. Ruling party MP Kamal Ahmed Majumder put forward some suggestions to improve

the budget. Majumder observed that the proposed budget would help reduce the gap between the rich and poor. But he suggested that the government should attach more importance to the development of the textile sector.

He thanked the finance minister for expanding the VAT net. but requested the minister to ensure that the tax given by the people go to the public exchequer.

Three women MPs — Jannatul Ferdous, Tahura Ali, Kamrun Nahar Putul — appreciated the Finance Minister's proposals to simplify taxation and banking laws, give in-creased subsidy in the agricultural sector and to withdraw duties from computers.

tions will stay in place for a very long time. There will be a requirement for concrete steps" before Congress will even consider lifting them.

At the same time, Inderfurth stressed that the United States considers both Pakistan and India friendly, responsible nations and wants to engage both of them in reducing tensions on the subcontinent.

To this purpose, Inderfurth said, the US is looking for India and Pakistan to take the following steps:

 refrain from weaponizing their nuclear capability or deploying the ballistic missiles each is working on; - halt the production of fis-

sile material: - participate in the Geneva negotiations on a Fissile Materials Cut-Off Treaty;

- sign the Comprehensive Test Ban Treaty (CTBT) without delay:

 make a formal pledge not to share the nuclear technology they have acquired with other nations; and

agree on a solid frame-

work to deal with their mutual differences, including Kashmir. Inderfurth said the Deputy Secretary of State Storbe Talbott had "a good meeting" with a special Indian envoy on June 12 and that the US is hoping to have similar in-depth discussions with the Pakistan soon.

Inderfurth also said that President Clinton would like to be able to visit South Asia in the fall, as had been planned. but that the Administration would have to evaluate how much progress Pakistan and India have made before decid-

JS proceedings

Live broadcast stopped due to objections by Opposition: PM

Hasina told the Jatiya Sangsad vesterday that the government had to stop live broadcast of Sangsad proceedings following "continued objections by the Opposition and an agreement reached with it."

"We're willing to revive the system but the four-point accord (signed between the gov-ernment and the opposition BNP) is blocking the way." she said, responding to two Jatiya Party lawmakers' demand for revival of live coverage by the Radio and TV.

Hasina recalled that it was her government which introduced live broadcast of the whole proceedings by the Radio and the question-answer session by the TV, which also put on air highlights of the day's business of the House.

The Prime Minister said, "We'll revive the earlier system of Radio-TV broadcast provided the opposition drops its earlier condition for selective broadcast as envisaged in the accord.

The stamp papers for all these wills have been purchased on the same date. The SB local office could not show any record to the BB team that these wills had been registered or will

be registered. Director Jahanara Begum mentioned that she owned a land in Mirpur from her father Dr Abdul Wadud through a will. But it was found that the will carries the signature of one Islam as the donor instead of Dr Abdul Wadud.

In the loan application, a certificate signed by an agricul-turist was attached which said there was no cold storage in Tangail, Mymensingh, Jamalpur or Sherpur districts. But the BB team found that one cold storage, financed by SB Tangail branch, is located in Tangail district and another one, also financed by the SB, is under implementation. The BB

team said the certificate, therefore, seems to be false. It was also found that the property valuation report of the directors hardly reflected any independent observation of the bank inspectors. The inspectors did not verify whether the

sponsors of the project actually owned the property. "If verified, a lot of serious irregularities/information would have come to light about

the wills and other issues," the BB report said. The credit report of the bank said that documents were sent

to SB lawyers for legal opinion about the ownership of the project land. However, SB local office could not show the BB team any record to support this statement. The local office in a letter on

June 7, 1998, had said that verbal discussions took place with the bank appointed lawyer about the ownership of land. This contradicts the information of the credit report.
