The total number of unemployed people in the country is 83.60 lakh, State Minister for Planning, Science and Tech-nology Dr Mohiuddin Khan Alamgir told the Jatiya Sang-

sad yesterday, reports BSS. Replying to a question from opposition BNP member Major (Retd) M Akhteruzzaman (Kishoreganj), the state minister gave a break-up of unemployed people on the basis of educational qualifications.

According to the statistics. the number of highly educated persons is 4,000, diploma engineers 10,000, engineers 5,000, doctors 5,000, post-graduates 26,000, graduates 1 lakh 10 thousand, HSC 13 lakh 37 thousand, SSC 21 lakh 19 thousand and below SSC 47 lakh 44 thou-

3,289 police personnel to be recruited

Home Minister Rafiqul Islam yesterday informed the Jatiya Sangsad that the government had a plan to recruit 3.289 police personnel during the fiscal 1998-99, reports BSS.

Replying to a question from Awami League member Shamsur Rahman Sharif (Pabna), the Home Minister said out of the total police personnel, 54 would be ASP, 227 male SI, 45 lady SI, 391 sergeants and 2570

constables. The minister said, besides, a proposal for creating the posts of about 10,000 police personnel during the fiscal year was also under active consideration of the government.

Dhaka welcomes Pak offer to resume talks with India

ISLAMABAD, Jun 24: Prime Minister Sheikh Hasina has welcomed Pakistan proposal to resume talks with India to discuss all matters, including the Kashmir issue, and for offering a non-aggression pact with India, report agencies.

In a statement to the press at the time of her departure from Islamabad ending a day-long visit here. Sheikh Hasina said that Bangladesh became a party to the NPT and a signatory to the CTBT because it felt that these treaties were a step towards achieving the ultimate

goal of nuclear disarmament. In her statement Sheikh Hasina said that during the talks her Pakistani counterpart Nawaz Sharif told her that nuclear tests carried by his country were "essential in the interest of preservation of Pakistan's sovereignty, territorial

integrity and independence as well as for regional peace and

stability. "Both the objectives, namely seeking ways and means to enhance bilateral cooperation and to increase my understanding on the nuclear issue that concerns us all in one way or the other, were fulfilled," she said in the statement.

The statement was read out by Foreign Minister Abdus Samad Azad after the talks between Prime Minister Sheikh Hasina and her Pakistani counterpart Nawaz Sharif that lasted about one hour and 20 minutes at the Prime Minister's

house in the afternoon. Sharif was assisted in the talks by Foreign Minister Gohar Ayub Khan, Population Minister Syeda Abida Hossain. State Minister for Foreign Affairs Mohammad Siddiq Khan

Kanju and Foreign Secretary Shamsad Ahmed.

Foreign Minister Abdus Samad Azad, Civil Aviation and Tourism Minister Mosharraf Hossain, State Minister for Foreign Affairs Abul Hasan Chowdhury and Foreign Secretary Mustafizur Rahman assisted Sheikh Hasina in the talks.

Bus journey to the capital from the northern district of Natore has now become much easier as the Bangabandhu Jamuna Multipurpose Bridge (BJMB) has reduced the journey

time by more than three hours. LYON, June 24: A fine 55thminute goal by Emmanuel Petit steered France to a 2-1 win over Denmark today, putting the home nation into the second round as Group C winners, reports AP.

France won a game that it dominated for long periods after a scramble in the penalty area. The ball was cleared to Petit, who hit a powerful leftfooted drive from 18 yards past Peter Schmeichel.

By beating Denmark, France becomes the first team to win its three opening games. South Africa's failure to beat Saudi Arabia in the other Group C match means that Denmark joins the host nation in the last 16 despite its defeat. Djorkaeff put France ahead

South Africans' hopes end

BORDEAUX, France, Jun 24: Two penalty kicks gave Saudi Arabia a 2-2 draw with South Africa today, ending the South Africans' remote hopes of making the second round in their first World Cup appearance, reports AP.

Sami al-Jaber scored in first-half injury time and Youssef al-Thyniyan netted in the 74th minute for the Saudis, who salvaged a point after two losses that ensured the team's first-round elimination and cost coach Carlos Alberto Parreira his job.

Shaun Bartlett scored in the 18th minute and added penalty in second-half injury time for South Africa, which needed to win and make up a four-goal deficit to Denmark in goal differential in order to advance. Although Denmark lost 2-1 to France in the other Group C finale, the Danes qualified along with the French from the group.

Both South African penal-ties were called on defender Pierre Issa, who had a forgettable World Cup. Issa also gave up an own goal in the Bafana Bafana's first game against France. To Issa's credit, the first call

was questionable. Chilean referee Mario Sanchez Yanten awarded the spot kick, even though replays showed Saudi captain Youssef al-Thyniyan fell to the turf despite the slightest touch from Issa's outstretched arm. The contact on the second penalty was initiated by the
