Minister for Public Works and Housing Mohammad Nasim told the Jatiya Sangsad yesterday that all unauthorised structures on the government land in different parts of Dhaka city would be demolished in phases, reports BSS.

Replying to a question from Hajee M Selim (AL-Dhaka), the minister said that notices had been served on the illegal occupants of the unauthorised structures including markets and slums to vacate the government

Nasim also informed the House that the government had a plan to dismantle the unauthorised structures outside Dhaka.

MYMENSINGH, July 5: A young girl of Chandpur village in Bhaluka thana here received serious burn injuries when a miscreant threw acid on her body on Sunday, reports UNB.

Family sources said the miscreant Nazrul, son of late Islam Mondol of the same village. threw acid on Sultana Razia Happy, 15, a student of class X of Mallikbari Shaheed Nazimuddin High School, while she was sleeping in her house at

She was rushed to Mymensingh Medical College Hospital the next morning in a critical condition.

Villagers said notorious terrorist Nazrul became angry as Happy's family refused his proposal to marry her.

The family of the victim did not dare to file a case against the miscreant for fear of further retaliation, they added.

Tofael urges BNP

Don't do politics with food price

Commerce and Industries Minister Tofael Ahmed yesterday urged the main opposition BNP not to do politics with a sensitive issue like food price saying this would only encourage the dishonest traders to increase the prices, reports BSS.

"None should do politics with the prices of food items to create artificial crisis," he said while responding to opposition allegations about the prices of essentials during a 30-minute unscheduled discussion ahead of adjournment of the house.

Tofael said prices of different items may rise sometimes for several reasons but the government has to take steps cautiously as the issue is sensitive. The newspapers too should play a responsible role so that the dishonest businessmen might not get any advantage.

He recalled with regret that the price of salt was increased following an opposition baseless and untrue campaign to create an artificial crisis. Several BNP legislators in-

cluding Shahidul Islam, Moshiur Rahman and Abdul Hye earlier took part in the discussion on different issues including the prices of essentials. Agriculture Minister Motia Chowdhury blasted the BNP for "taking a strategy" to create an artificial crisis of rice through planned propaganda.

"I categorically want to say that currently we have a reserve of three and half lakh tonnes of rice with the procurement of two lakh tonnes during the current season," she said adding "there is no scope to create any crisis centring the stock of

She, however, said the prices of some vegetables might have gone high in some parts of the country because of the current transition season of agriculture and temporary dislocation in transportation.

Treasury Bench members Khan Tipu Sultan and Abdul Latif Mirza also took part in the discussion.

Replying to AL lawmaker Kazi Keramat Ali on outstanding dues in jute buying, Faizul Haq said he had inherited outstanding dues worth Tk 90 crore when he took over charge of the ministry, but the amount has now dropped down to Tk 42 crore. "We'll clear the dues belore the onset of next jute procurement season," he told the parliament.

Replying to a question from M Fazlur Rahman Khan (AL-Netrokona), the minister said that the government had no plan to introduce intercity train service between Dhaka and Mohanganj route. He said that the condition of railway tracks in Mymensingh-Mohanganj section was not fit for the running of inter-city trains.

Tk 18 cr Someshwari river management project soon

Water Resources Minister Abdur Razzak yesterday said the government would undertake a project of about Taka 18 crore for management of the River Someshwari to save adjoining areas from erosion in Durgapur thana under Netro-

kona district, reports BSS. Responding to a call atten-tion notice of Md Jalaluddin Talukder of Awami League from Netrokona, the minister said the project would be undertaken with financial assistance from Canadian International Development Agency (CIDA).

He said the government was pursuing discussion with CIDA for taking up the project as early as possible.

In his call attention notice Jalaluddin Talukder said the Someshwari river has left a trail of devastation on both its banks over the years. It is now threatening more areas including several bazaars, the thana headquarters. Durgapur thana hospital and its staff quarters. the magistrates court, thana parishad bhaban. 
