the administrative building but were obstructed by police. The students then turned violent and threw brickbats at the offices of the VC, pro-VC and Treasurer in the administrative

building, damaging window-The agitating students later went to the residence of the VC and tried to enter it. Obstructed by police, they threw brickbats

at them. One of the demonstrators was injured there. They also threw brickbats at the VC's residence. Then they returned to the Aparajeya Bangla, held a rally and announced the strike programme

from the rally. The GCO brought out a procession on the campus to drum up support for their strike.

Jatiyatabadi Chhatra Dal (JCD), student wing of the BNP also extended support for the strike from a rally on the cam-

manding withdrawal of the decision to raise tuition fees. Later in the evening. Vice

Chancellor Prof A K Azad Chowdhury at a press conference at the administrative building condemned the attack on his office by students. The VC justified the decision to raise tuition fees and other
