#### Clinton proposes summit with Obuchi Sept 21

TOKYO, Aug 1: US President Bill Clinton called Japan's new Prime Minister Keizo Obuchi today and proposed a summit meeting in late September, a Foreign Ministry official said, reports AP.

Clinton told Obuchi that he hoped to talk about economic conditions in Japan and other Asian countries at the meeting, according to a ministry official who spoke on condition of anonymity.

The US President also congratulated Obuchi on the inauguration of his new Cabinet, he

Clinton proposed the sum-mit be held on September 21, when he will be in New York for a United Nations meeting.

Obuchi said he will try to arrange a visit after reviewing domestic events and parliamentary schedules, the ministry officials said.

#### Khaleda did not say anything about Mujib's killing: BNP

BNP secretary general Abdul Mannan Bhuiyan yesterday made it clear that the party chairperson Begum Khaleda Zia did not say anything against or in favour of the killing of President Sheikh Mujibur Rahman in 1975, reports UNB.

Begum Zia has asked the government to take lessons from the history and reminded the tragic consequences of ignoring the demand of the people, resorting to political repression and blocking the democratic process of changing the government, Mannan Bhuiyan said in a statement last night.

Awami League general secretary Zillur Rahman and State Minister for Information Prof Abu Sayeed, reacting sharply to the reported speech of Begum Zia on July 29, said the Opposition Leader favoured the August 15, 1975 killing and wanted to protect the accused of the killing who are undergoing

Refuting the allegation he said Begum Zia described the law and order situation in the country, violation of human rights enshrined in the Constitution and the deterioration of the country's economy. The situation isolated the government from the people.

The BNP secretary general asked the ruling party leaders to refrain from making such allegations. He said the government could not escape from the reality by trying to defame Begum Zia and launching repression on the people.

The Palash Urea Fertilizer Factory needs 17 million cubic feet of natural gas everyday to run on full capacity. It is now running with less than 60 per cent capacity, the sources said.

Article 27 of the Constitution says: All citizens are equal before law and are entitled to equal protection of law.

Article 31 says: To enjoy the protection of the law, and to be treated in accordance with law, and only in accordance with law, is the inalienable right of every citizen, wherever he may be, and of every other person for the time being within Bangladesh and in particular no action detrimental to the life, liberty, body, reputation or property of any person shall be taken except in accordance with

Article 35(3) says: Every person accused of a criminal offence shall have the right to a speedy and public trial by an independent and impartial court or tribunal established by

NEW YORK, Aug 1: The Eco-nomic and Social Council of the United Nations (ECOSOC) at its session recently has adopted a resolution recommending to the UN General Assembly for proclamation of the year 2005 as the international year of

microcredit', reports BSS.

The proposal for proclaiming year 2005 for international year of microcredit was made by Bangladesh Prime Minister Sheikh Hasina in her message to the Microcredit Summit councils, held in New York on June 25 this year. It was pre-sented to the ECOSOC by the "Friends of the microcredit at the UN," an informal group of distinguished ambassadors and permanent representatives to the UN who are strongly supportive of microcredit pro-

The proclamation of the year would give an impetus to the under-taking by the microcredit summit, which aims at working to ensure that 100 million of the world's poorest families, particularly women of those families, receive credit for self employment by the year 2005. This was a goal adopted by the Microcredit Summit, held in Washington DC which was co-chaired by Prime Minister Sheikh Hasina last year.




