Bangabandhu was assassinated by defeated forces: Zillur

LGRD and Cooperatives Minister Zillur Rahman yesterday said that the Father of the Nation Bangabandhu Sheikh Mujibur Rahman was assassinated by the defeated forces of the liberation war in a bid to reestablish Pakistan in independent Bangladesh, reports BSS.

That is why, he said, the national constitution presented by the Bangabandhu government was struck and secularism, one of the four main pillars, was deleted undermining the very concept and spirit of the war of liberation.

Zillur Rahman, also the general secretary of Awami League, was speaking as the chief guest at a discussion meeting marking the National Mourning Day.

Organised by the Awami Ainjibi Parishad, the discussion was held at the National Press Club auditorium.

Water Resources Minister Abdur Razzak, Vice-President of Bangladesh Bar Council Barister Amirul Islam, Chairman of Bar Council Sudangshu Shekhar Haldar, noted journalist M R Akhtar Mukul and Dhaka Ainjibi Samity president Sardar Mohammad Nuruzzaman also spoke on the occasion.

In a separate message, Prime Minister Sheikh Hasina greeted Hungarian Prime Minister Viktor Orban on the same occasion.

Japan donates \$5.2 lakh to ICDDR,B

The government of Japan donated \$5.20 lakh US dollars to the International Centre for Diarrhoeal Disease Research, Bangladesh (ICDDR,B) as part of its 1998 annual contribution, reports BSS.

Japanese Ambassador to Bangladesh Yoshikazu Kaneko handed over the cheque to the Interim Director of ICDDR,B Dr George Fuchs, said an embassy press release yesterday.

The contribution will be used to meet ICDDR,B's activities in the clinical sciences and the laboratory sciences division. The Japanese grant will also be used for the centre's SAARC fellowships and training activities.

In 1997, the government of Japan funded six training programmes out of 12. These highly successful training programmes have benefited 53 participants from Bangladesh as well as from Asian and African countries.

In 1996-97, the Japanese government also funded the construction of a new international family planning training centre at ICDDR,B's Matlab facility, the press release added.

Thereupon Home Creations Limited has undertaken construction of a multistoried apartment building named Trellis Garden on the Schedule property upon obtaining loan facilities from a bank by mortgaging the Schedule property after taking necessary clearance from RAJUK, and it has also sold the apartments to various buyers who have already paid part of the consideration.

In the circumstances, the right, title, interest and possession in the Schedule property belongs to Home Creations Limited. The purported revocation of the Power of Attorney by the said Farah Rita Khan is illegal and not binding on Home Creations Limited and anyone who has purchased the apartments from it, in view of the fact that the right, title, interest and possession in the Schedule property was already sold and transferred to Home Creations Limited by the said Constituted Attorney long before its purported revocation. Such purported revocation of the said Power of Attorney by the said Farah Rita Khan does not affect the right, title, interest and possession of the Home Creations Limited in the Schedule Property in the least. The right, title, interest and possession of Home Creations Limited in the Schedule property is fully protected by Section 53A of the Transfer of Property Act. Besides, the said Power of Attorney being irrevocable and the said K Z Mahmud having had an interest in the Schedule property, he is an irrevocable agent under section 202 of the Contract Act, which cannot be terminated by the Principal Farah Rita Khan.
