#### Salda gas wells

#### PM asks BAPEX to submit project proposal

By Staff Correspondent Prime Minister Sheikh Hasina has directed BAPEX, the only Bangladeshi oil and gas exploration unit, to submit a project proposal for drilling

two new gas wells at Salda. The Prime Minister gave the directive while visiting the Energy Ministry yesterday evening, sources said. This is the first such instruction given by the Prime Minister in favour of the national exploration company which discovered 10 gasfields since independence.

BAPEX had struck and small gasfield near Salda River area under Kosba thana of Brahmanbaria district, near the Indian border in early 1996. It started supplying around 15 million cubic feet of gas per day since March last through a single well. The single well project was implemented at a cost of Tk 25 crore.

The sources said that BAPEX had long been requesting the authorities to allow it to drill See Page 12 Col 2

#### 50 BNP lawmakers deposit resignation

Under the five-day drive which began on Sunday, BNP whips are assigned to sit at the Chief Whip's office by rotation and receive the resignation letters. Whip Amanullah Aman was on duty yesterday. Aman told newsmen he received some letters but he could not give the number of those.

The special drive was initiated in the wake of slow progress in the process of de-

positing resignation letters. According to party sources, some 50 of the 110 BNP MPs have so far deposited their resignation letters. The move is unlikely to go faster unless a meeting of the BNP parliamentary party is held before the next session of parliament begins on September 7, some MPs willing to debate the issue in that meeting said.

#### Flood waters may recede slowly

By Staff Correspondent Duration of the floods this year may prolong further as the swelling flood waters might take more time to recede because of the imminent spring tide, according to a flood con-

trol expert.

"If the levels of water in the Padma and Jamuna reach their peak simultaneously then the damage of flood this year will be more than any other year, said Prof Jahir Uddin Chowdhury of the Institute of Flood Control and Drainage Research at BUET.

The water level of Brahma putra-Jamuna reaches its annual peak in late August from heavy monsoon rainfall. The water level of the Ganges starts rising in June/July and attains its peak in late August or early September," Dr Chowdhury

## Cabinet decision to seek flood aid

The government has decided to seek international assistance to implement its post-flood rehabilitation programmes, although it was initially reluctant to ask for any foreign help in this regard.

The decision was taken at the weekly cabinet meeting yesterday. Prime Minister Sheikh Hasina had expressed her reluctance in the first week of this month. "The flood has now proved to

be really devastating. It has already damaged lot of property. destroyed crops and infrastructure across the country. In the changed circumstances, the government has decided to seek foreign assistance to cope with the flood situation," Law, Justice and Parliamentary Affairs Minister Abdul Matin Khashru told The Daily Star last night.

However, the cabinet decided the priorities of the rehabilitation programmes and felt that the government should clearly communicate to the international organisations concerned

as to what kinds of relief materials the government expects from them.

The question of informing the donors the specific needs arose out of past experience.
"After the devastating 1988 floods, the foreigners had sent, along with other materials, items like suits, pants, sleeping gowns and so on which were of no use to the flood victims," said a minister seeking anonymity. "In 1988, the gov-ernment received helicopters for relief operation, while it had to spend lot of money for fuel and food (procured from five star hotels) for the heli-

copter crew". The cabinet observed that foreign assistance would be needed for procurement of food and medicine, repair and reconstruction of houses, educational institutions, roads and railway tracks, collection of seeds and so on.

## If Zia was not a conspirator, he was an inspiration : SPP

"If General Ziaur Rahman was not a conspirator, he can be said to have inspired the killers of Bangabandhu," Special Public Prosecutor in the Bangabandhu Murder Case told the court yesterday, reports UNB. SPP Serajul Haq quoted a
