- The Government of the People's Republic of Bangladesh has approved the implementation of a Site Preparation Contract for a Power Project at a new site at Meghnaught 22-km south-east of Dhaka city and has agreed to allocate the necessary funds for implementation of this part of the project. It is intended that the proceeds of this fund will be applied to eligible payments under the design and build (turnkey) contract for the implementation of this part of the project. The proposed conditions of contract is the FIDIC Conditions of Contract for Design-Build and Turnkey First Edition 1995.
- The Bangladesh Power Development Board (BPDB) now invites international tenders for the design and implementation of a Site Preparation Contract for the Meghnaught Power Project. The Site Preparation Contract will entail substantial raising of the formation level of a site on the north bank of the river Meghna just downstream of the Meghna Bridge.
- The site area to be filled is an area of approximately 100 hectares with an estimated volume of approx 6.4 million cubic meters. The hydraulic fill is to be sourced from approved locations in and around the Meghna River to raise the site.
- River embankment protection to the filled site is required on three sides with a total length approaching 3.4-km and a protective embankment on land to the fourth side with a length of approximately 800 meters.
- All works under the design and build (turnkey) contract (Section 1, 2, 3) shall be completed within 300 days. However, all works under Section 1 & 2 shall have to be completed within 155 days from date of award of contract.
- The tenderers will be expected to be suitably qualified to undertake a work of this type and size. The tenderer shall furnish with his tender satisfactory evidence of his capability, past experience record, adequacy of resources to carry out contract and reports on the financial standing of the tenderer. Tenderers will be expected to own or have lease on suitable dredging plant to complete work in the stipulated time and have undertaken similar as this project in the last 5 years.
- A complete set of tender documents (Site Preparation Contract) will be available for purchase with effect from 29/98 on submission of a written application to the Director of Purchase, BPDB, WAPDA Building (9th Floor), Motijheel C/A, Dhaka-1000 and upon payment of Tk. 20,000 (twenty thousand) only (non-refundable) in the form of Pay Order/Demand Draft in favour of the Director of Purchase, BPDB.
