


# COMMISSIONING CEREMONY


#### MESSAGE

On Oct 16, 1997 Khulna Power Company Limited ("KPCL") signed a fifteen (15) year Power Purchase Agreement ("PPA") with the Bangladesh Power Development Board ("BPDB") to build, own and operate a 110 MW barge mounted power plant ("Project") in Goalpara, Khulna District.

KPCL is a special purpose company established to develop the Project. Initially, KPCL consisted of Wärtsilä NSD Power Development ("WNSDPD") and two Bangladesh based firms, Summit Industrial & Mercantile Corporation (Pvt.) Ltd. ("Summit") and United Enterprises & Co. Ltd. ("United"). Coastal Corporation, a U.S. based Fortune 500 company is now the majority owner. Coastal's primary activity is the supply of fuel, particularly natural gas, around the world as well as ownership of several power plants intentionally. Wartsilä is the world's largest manufacturer of medium speed reciprocating engine technology and currently has plants in over 100 countries, including 1,400 MW in India and over 500 MW in Pakistan. Jointly and separately Summit and United have extensive experience in project execution, civil construction, waterways transportation and trading.



The Project consists of two separate Wartsila NSD Power Commodore Barges. Each Power Commodore Barge is about 55 MW and has been registered in Panama under the name of Tiger I and Tiger III. Due to the previous registration of the name Tiger II with another vessel, KPCL elected to utilize Tiger III The Project site allocated by BPDB is near the existing Khulna Power Station on the bank of River Bhairab and therefore minimum modification to the existing sub-station and transmission line was required.

Being the first ever private power plant selling to the BPDB, KPCL faced several challenges, however, through the strong cooperation and support of the BPDB, MEMR and other concerned Ministries, KPCL was able to implement the Project on schedule. To make the Project a success, simultaneously, work was taking place in three separate continents. In Asia, site works commenced in Khulna to accommodate the Power Commodore barges and other auxiliary facilities as well as the construction of the barge plant in Singapore, where many Bangladesh nationals also worked on the Plant. In Europe, the reciprocating engines were finalized in Wärtsilä's manufacturing facilities in Finland. In the United States, the International Finance Corporation ("IFC"), the private arm of the World Bank, commenced its evaluation of the Project.

Over 100 permanent jobs with the Project have been created as well as several hundred jobs during the peak of the civil site construction. KPCL and its sponsors have also participated in various social development programs in the country such as the Prime Minister's Flood Relief Program, Assistance for Blind Children, and Technical Education Program for primary school children. KPCL looks forward to its continued participation in Bangladesh's social and physical infrastructure.

MESSAGE

The Hon'ble Prime Minister Sheikh Hasina has given priority to the development of the power sector. In my understanding, it is the Government's explicit aim to eliminate power shortages as soon as possible so to be in a position to keep up with the anticipated growth in the economy with corresponding availability of power.

The introduction of KPCL power into the national grid is a substantial boost to the process and particularly in the supply of electricity in the western zone of Bangladesh. Equally important, it has paved the way for the realisation of future private investments in new and existing electricity generating capacity.

It is also a reassurance for the Government that the policy package announced in October 1996, designed to attract international investments and finance into the private sector, has received an overwhelming response. I believe, KPCL has set a trend that will hopefully be followed by others in future. I presume the project has also allowed Bangladeshi talents to participate in this relatively low risk new venture. Our local financial institutions and capital market may like to observe and participate to develop and to respond to future



In the light of KPCL's success, I, on behalf of my colleagues in BPDB, wish to express hearty thanks to the management of the Company for the commitment demonstrated during the past two years in working together to bring the project to a happy conclusion.

The KPCL project at Khulna is Bangladesh's flagship in terms of the development of internationally credible private power projects. Its success is due to the successful cooperation of the Government, BPDB, the sponsors, financiers and the contractors. I would like to extend my heartiest congratulations to them all.

Finally, I am particularly delighted to be here on this inauguration ceremony also because I was also present on 5 December 1997 when the Hon'ble Prime Minister inaugurated the ground breaking ceremony.



MESSAGE


