House ready to deny Clinton \$18b IMF money

WASHINGTON, Sept 17: Despite urgent pleas from President Bill Clinton, the House is ready to deny the full 18 billion dollars he is seeking to help the International Monetary Fund replenish coffers depleted by the world's widening economic crisis.

approve only 3.4 billion dollars for the IMF, following the lead of its Appropriations Committee. That's far below the 18 billion dollars the president earlier this month went along with.

The foreign aid bill also would torpedo a vital component of an agreement reached four years ago between the United States and North Korea. The provision bars the congressional release of 35 million dollars to finance fuel deliveries to North Korea.
