**PM visits ICDDR,B
600 patients coming daily**

Prime Minister Sheikh Hasina yesterday visited the International Centre for Diarrhoeal Diseases Research, Bangladesh (ICDDR,B) to see the condition of patients being treated at the hospital at Mahakhali, reports UNB. She visited the various units of the hospital, including the nutrition ward, where severely malnourished children are getting treatment. The malnourished children are being provided with a special diet of locally available foods such as khichuri and halua that are high in calorie and nutrition. Some 600 to 700 patients suffering from diarrhoea are getting admission to ICDDR,B daily since the recession of flood waters, hospital sources said. In last 24 hours, some 620 patients were admitted to the hospital, ICDDR,B Director Dr George Fuchs told the Prime Minister during her visit.

On Sunday, some 724 patients were admitted, hospital sources said adding that in August a total of 21,512 patients attacked with diarrhoea got treatment from this centre. The number of patients increased in the current month. A huge number of patients were shifted to makeshift units of the hospital to cope with the exodus of patients. The Prime Minister went round the different units and talked to the patients.

Talking to Dr Fuchs, the Prime Minister thanked the hospital authority and said "You are doing a wonderful job to save the people of this country."

Health Minister Salahuddin Yusuf, State Minister for Health Prof M Amanullah and physicians of the centre, including Dr M A Salam, Prof Barkat A Khoda, Prof Mathan and Dr Farnisco were present during the visit of the Prime Minister.
