Boy killed in road mishap

From Staff Correspondent SYLHET, Oct 17: A 10-year-old boy was crushed under the wheels of a speeding truck on Sylhet-Sunamganj Road on

Thursday afternoon. The accident took place at a place near village Ghopal at about 2:30 pm as the killer truck hit the boy causing his spot

death. The driver managed to escape after the accident. Agitated villagers put up barricade on the road. The road was cleared by police after five hours.

Tk 22.37 cr fish resources damaged

NOAKHALI, Oct 17: The prolonged devastating flood of this year caused extensive loss to fish resources worth about Tk 22.37 crore in the district, reports UNB.

The district Fisheries Department sources said, some 30,510 ponds of six thanas were washed away resulting in losses to 5,608 tons of various species of fish. Besides, shrimp cultivation has been affected adversely. The owners of projects said some 19 metric tons of shrimps were lost in the calamity. Only 20 to 50 projects could be saved from the catastrophe. Most of the shrimp enclosures at the coastal belts have been washed away, they added. Besides, extortionists damaged a number of shrimp enclosures in the district for failing to collect money, the owners alleged

Shortage of pry school teachers

BANDARBAN, Oct 17: A total of 4,945 students in the district are being deprived of primary education due to shortage of teachers at different government primary schools, reports UNB.
Official sources said 23,385 students are studying at 219 primary schools. Only 461 teachers are engaged in teaching the students against the total requirement of 565. The Local Government Parishad alleged that the recruitment of primary teachers in the area is being hampered for obstruction of the Janasanghati Samity here. The parents of deprived students urged the higher authorities to take immediate steps to fill up the vacant posts.

Fishermen in miseries

SHARIATPUR, Oct 17: Fishermen of the district are facing hardships as the rivers and other water bodies are drying up due

to want of proper dredging, reports UNB. Most of the water bodies have dried up and chars emerged in river beds hampering fish output. They said the water bodies are turning into plain land due to lack of care by authorities concerned. According to a survey, there are four rivers and about 2,000 canals and other water bodies in the district and the rivers have lost the navigation due to accumulation of silts. Chars emerged in these rivers are being used for cultivating of various crops including 'Boro' paddy.

Man commits suicide

NAOGAON, Oct 17: A middle aged man of village Shoilagachhi in sadar thana alleged committed suicide by taking poison due to his inability to repay the loan taken from a money-lender at a high rate of interest, reports UNB.

Family sources said, Abdur Rahman, son of Abdul Jabbar borrowed money from a money-lender of Raninagar thana to carry out his hotel business. Due to adverse situation he could not repay the loan in time that afterwards stood a big amount with the accumulation of interest. Meanwhile, the moneylender started pressurising him to repay the money. Finding no other way out, the victim took poison in the morning of October 9. He was rushed to a local Health Complex and later shifted to the district Sadar Hospital where the attending physicians declared him dead.

Rly lands under illegal occupation

NOAKHALI, Oct 17: About five acres of valuable Railway land in the district are under the illegal occupation of a vested quarter, reports UNB.

According to the local people, with the help of some dishonest Railway Estate Department officials and employees the group constructed slums, shops and business centres adjacent to the rail stations of Sonapur, Choumuhani, Sonaimuri and Delta and earning a lot depriving the government of huge revenue. For years together these lands remained out of the railway's possession mysteriously. It was learnt that several attempts were taken to evict the unauthorised occupies which ended in failure due to the influence of certain quarters.

Ex-UP chairman sued


KURIGRAM, Oct 17: The District Anti-Corruption Bureau has filed a case against a former UP chairman of Bhurungamari thana on charge of misappropriation of Tk 20,000 of an ADB project, reports UNB.

According to official sources, Abul Hossain, former chairman of Shilkhuri union parishad misappropriated Th 10,0000 allocated for construction of a tin-shed classroom of a primary school at Uttar Dhalbhanga and another amount of Tk 10,000 allotted for reconstruction of roads during his tenure. The project was undertaken during the fiscal 1995-96 financed by Asian Development Bank (ADB). Mohammad Fazlul Bari, Assistant Inspector of the Bureau, filed the case with the police station on September 30 after investigation.

Wheat allocated by Relief Deptt

PIROJPUR, Oct 17: A total of 520 metric tons of wheat have been allocated by the Relief and Rehabilitation Department under Test Relief (TR) programme during the current fiscal year here, reports UNB.

Official sources said of the wheat sanctioned under the rural infrastructure maintenance scheme, some 79 metric tons have been allotted for Vandaria, 56 mts for Kaukhali, 106 mts for Mathbaria, 89 mts for Nazirpur, 97 mts for Nesarabad and 93 mts for Sadar thanas. The wheat will be utilised against the earth filling works of fields of different educational and religious institutions.

One gets jail term for keeping arms illegally

From Staff Correspondent BARISAL, Oct 17: One person was convicted for 10 and 7 years rigorous imprisonment (RÍ) for keeping arms illegally.

Jamal Hossain Chakider was convicted under sections 'KA' and 'CHA' of Arms Act in the court of Abdul Kuddus Mia Judge of the Special Tribunal-2 here on Thursday.

Another alleged accused Iran Hossain was acquitted of the charges. Jamal's imprisonment for both sections will continue simultaneously. He was tried in absentia. The case hsitory in brief is, Barisal Kotwali Police acting on a secret information earlier arrested Iran Hossain but no arms were recovered from his possession. Later on according to his confessional statement, police raided the house of Jamal Hossain Chakider at Bhasenchar village in the kotwali thana on 23 June 1997 and recovered a country made revolveer with three rounds of bullets. But Jamal managed to eseape. He is still absconding. Police after investigation submitted chargesheets.

Erosion takes alarming turn ın Jamalpur

JAMALPUR, Sept 17: Erosion of the rivers Jamuna and Brahmaputra has been continuing unabated. The rivers have already devoured a vast track of land in the district.. Residential areas, educational institutions, market, embankment and railway ferry ghat have been threatened by the erosion.

Like every year, the devastating erosion has once again taken a serions turn with the rise or recession of water level in the rivers. This year too, erosion has forced thousands of people homeless. The rivers have already devoured several acres of corps land.

About 50,000 people mostly poor, have taken shelter on roads and others places. The Bahadurabad railway ferry ghat, which was earlier shifted to new sites on several occasions needs shifting again as the river continues to engulf the sorrounding areas.

Measures taken so far by the concerned authority to chek the erosion in the district were inadequate. Thousands of acres of land have been engulfed by the rivers' erosion during the past few years. This trend has seriously affected the crop output in the district. This year too standing crops were affected by both erosion and flood.

According to unofficial sources, more than 26 square km areas in five unions of Islampur thana, two unions of Dewanganj thana, three unions of Madarganj thana have been washed away by the rivers' erosion in the last five years.

The worst erosion affected unions are: Kulkandi Belgassa, Ehinaduli, Nowarpara and Shapdahri in Islampur thana, Éhikajani, Bhadurabad. Charamthana and Chukaibai in Dewanganj thana. Mhamudpur and Nayanagor in Melandah thana, Balijuri and Charpardah in Madarganj

The erosion in the district continues to affect the rural poor people who have lost at least 2,5000 acres of land in the

past few years. It was alleged that the erosion -hit people were not provided with any relief goods. Many of the victims have fallen sick and need urgent medicare.

The severe erosion has also threatened many buildings and similar structures. The 1,000-



British HC, Samata stand beside flood victims

PABNA, Oct 17:Samata, a Non-Governmental Organisation (NGQ) has undertaken a massive emergency flood relief and rehabilitation programme with the financial assistance of the British High Commission in Bangladesh.

Initially Samata distributed relief materials with the assistance of DFID, Bangladesh among the flood victims of Shanthia, Bera, Sujanagar Sadar, Gurudaspur, Boraigram thanas in Natore district and Shahjadpur, Ullahpara, sadar, Tarash thanas in Sirajgonj district and other districts of Bangladesh.

Samata has been formed a strong and capable network of 28 NGOs to operate emergency relief works and post flood rehabilitation programmes in the districts of Pabna, Natore and

Sirajgonj. Their distributed materials include two kg inflated rice and 250 gm molases to each family in the first phase among 5,000 families through NGOs' network with the assistance of DFID, Bangladesh.

Samata also distributed 20 kg rice, three kg pulse, five kg potato, one kg salt and one kg soybean oil among 25,000 flood stricken families with assistance from the same donor agency.

The officials and employees of Samata also distributed relief materials among the flood victims with thier salary of three days. To cope with the deteriorating health situation following recession of flood waters, Samata has also drawn up a long run programme of dis-tributing medicine and health care facilities for preventing water-brone diseases like diarrhoea, dysentery and jaundice in Pabna, Natore and Sirajgonj districts. With the assistance from DFID, Samata has set up four satellite clinics in 14 flood affected areas. It will continue for the next two months.

Medicine worth Taka two lakh and one-lakh packets of orsaline have been distributed through these clinics. Four MBBS physicians and a good number of para-medics have been working at these clinics day and night. At present Samata has been distributing rice, pulse, potatoe, salt, soybean oil and money among 32,00 flood affected families with help from the same donor agency and 6000 families with the assistance of IVS, USA.

Besides, Samata has also distributed winter vegetable seeds worth 5,000 taka among 10,000 flood stricken families in the above mentioned areas with the help from Bread for the World, Germany. At present Samata has undertaken a massive post-flood agricultural rehabilitation campaign worth 56 lakh taka with the help of Proshika Manobik Unnyan Kendra.
