Captive Dhaka tastes freedom

at six

By Sabir Mustafa Dhaka breathed the sweet air of freedom again yesterday evening, after being kept captive for three days and two nights by political activism of the mindless kind. As the 60hour hartal imposed by the main opposition Bangladesh Nationalist Party and its allies drew to a close, the city stirred again and rose from the dead.

Shops began to re-open early, some hours before the 6:00 pm deadline, public transport began to hit the road from around 4pm but owners of private cars stayed away till the threat of mob attacks, indiscriminate bomb blasts and clashes between rival groups were finally gone.

By 8:00 pm, the once-throbbing city turned into a ghost town came alive again, as people rushed to visit relatives. went to shops to replenish depleted kitchens, took patients to hospitals.

While the end of the hartal released the city from enforced captivity, it still left a bitter taste in the mouths of citizens who saw three precious working days frittered away by political jingoism.

The hartal is a gross violation of our human rights," said a Dhaka resident. "The hartal denied us the right to free movement and the right to make a conscious choice".

"What kind of a democracy is this, when people's freedom of movement can so easily be violated by a hartal?" said another resident who kept his Dhanmandi shop closed out of

For 60 hours, only rickshawspullers dared defy the hartal, as compliance would have pushed these day-labourers and their families to the door of starvation. Others could not travel to their place of work, children were forced to stay away from school, shops and markets lost three days of revenue.



BNP's marred Paltan meeting stirs storm in parliament

The Jatiya Sangsad yester-day witnessed a stormy debate between the government and the main opposition BNP holding each other responsible for thwarting the latter's November 7 public meeting at Paltan Maidan in the city.

Besides, some other controversial issues that dominated the national politics over the past few days also came up in both the rounds of the fiery debate, separated by the day's scheduled businesses.

Other issues include: series of clashes between the rival groups during the nationwide 60-hour hartal that ended yesterday evening. BNP chief Khaleda Zia's staying at a residence in the Dhaka Cantonment and the alleged linkage of the opposition agitation to the historic judgment in the Bangabandhu Murder Case.

The unscheduled debate, participated by ten members in the Treasury and the Opposition benches, started minutes after the BNP lawmakers returned to the House at 6.30 pm, ending their 60-hour hartal since Monday morning. The BNP MPs refrained from attending the session on Monday and Tuesday. However, none of the three MPs of the Jamaat-e-Islami, another sponsor of the hartal, did not attend yester-

day's sitting of the Sangsad. The hartal, the longest of its kind since the Awami League came to power 29 months ago. was enforced to protest, among other issues, foiling of the November 7 public rally and the killings during the just-ended general strike across the coun-

During the debate, members in both the sides shouted and hurled abuses at each other and jumped to their feet, frequently disrupting the proceedings.

Rising on a point of order. Deputy Leader of the Opposition Prof. AQM Badruddoza Choudhury opened the debate accusing the government of depriving his party of its constitutional rights for holding public gath-

He accused the ruling party "terrorists" of hurling crackers and the police of firing teargas shells at the Paltan Maidan where a BNP rally was in progress on Saturday.

Amid shouts by some AL lawmakers, Choudhury went on alleging that the AL activists also attacked processions marching towards the meeting venue around the Paltan Maidan on that day. Describing the acts of terror-

ism that foiled the rally halfway, he further alleged that police lobbed teargas canisters targeting Khaleda Zia on the podium as well as on her car parked nearby. "It was an attempt on her life", he remarked. Interrupted by shouts from

across the bench, the deputy opposition leader blamed the top government leaders for issuing untrue statements on the floor of the House regarding the November 7 incidents.

"We called a two-day hartal on November 9 and 10 to protest the government action against our holding of public rally and it was later extended as three pro-hartal activists were killed", Badruddoza Choudhury explained,

Agri loan up to Tk 15,000 to be rescheduled

The government has decided to reschedule agricultural loans up to Tk 15,000 taken by the farmers since 1996-97 fiscal year, reports UNB.

Finance Minister SAMS Kibria said this in Parliament yesterday, replying to Md Wazi Uddin Khan (AL-Pabna).

The minister said the instalments of loans, taken before fiscal 1997-98 and already fixed for payment during the last and current fiscal years, will also be rescheduled.

He said the government has decided to make a huge investment in the country's agriculture sector for ensuring successful implementation of the postflood rehabilitation programme.

The government attached priority to this sector, Kibria said, adding that the amount of total loan for the farmers is unprecedented in the country.

In reply to another question, he said a total of Tk 8,007.40 crore was earned as import duty during the last fiscal year.

JP leader killed in Khulna

leader of the bazar committee sparked off tension in the area and a mob went on rampage. Eye witnesses and police said the mob put up barricades on roads, disrupting transmovement on Khulna-Jessore highway till 4 pm. They damaged several cars and shops.

NCBs' loan to Shinepukur raises questions

Three Nationalised Commercial Banks (NCBs) are taking a Tk 70 crore consortium loan exposure on Shinepukur Holdings Ltd, which many think is too big a risk being taken without adequate analy-

sis and safeguards. The role of the lead bank for the loan, Sorrali Bank (SB), has become even more controversial for deviation from norms it permitted to push the project

SB has already disbursed Tk 35 crore loans to Shinepukur, a sister concern of Beximco Group which has colossal loan liabilities with SB amounting to Tk 158 crore. Some of its loans have been rescheduled many times and on extraordinary terms.

Janata Bank (JB) and Rupali Bank (RB), the other members of the consortium, have also approved the loan but are yet to disburse the money.

RB sources said they are waiting for a 'joint assessment

of the project. But this becomes a mockery as the loans have already been approved by all and

already disbursed in one case. JB approved the loan although many of its own conditions to clear the project remained unmet. Both JB and RB have not been able to accurately evaluate the project costs and viability. But they acted on the basis of SB's evaluation, which many think is not fully correct.

The loan has also created controversy because of its nature -- part of it will be used for purchase of land. Land purchase is neither an industrial activity nor a trade for which banks seldom, if ever, provide finance.

Experts say when the government's policy is to rehabilitate the flood-affected industries, 'such wasteful' loans should not be allowed.

The story of Shinepukur's loan goes back to the middle of this year. It proposed to buy land and develop two townships, Sun City at Savar and

Gulshan Lake Town at Badda. The company said it had purchased 4.3 acres of land at Badda and 67.86 acres at Savar investing approximately, as it claimed, Tk 44 cr.

Shinepukur said it would purchase additional 10 acres of land at Badda and 60.14 acres at Savar, for which it had made additional initial payments.

To get the money, Shinepukur in July this year planned to raise 17 million dollars from the international finance market under an 'unconditional guarantee' from SB. The loan was arranged from ANZ Investment Bank in Lon-

The kind of 'unconditional guarantee' by SB had surprised financial experts who termed it 'highly unusual', specially in favour of a company which is facing charges of manipulation in the share market and whose sister concerns borrowed tens of crores of taka under ficti-See Page 11

Occidental awaits PSC renewal

The government may extend US company Occidental's PSC for blocks 13 and 14 after "successful negotiations" over a Tk 600 crore compensation claim by the Directorate of Environment, sources said.

Sources said Petrobangla and Energy Ministry have "cleared" Occidental's file regarding extension of its PSC following "detailed negotiations with and clarifications from Occidental". The file was expected to be cleared by the prime minister three weeks ago. the sources said.

But as the extension is being delayed. Occidental's high officials from USA are now in the city for talks on the environmental claims of the govern-

In a meeting with Environ-ment Minister Sajeda Chowdhury Tuesday. Occidental offi-cials agreed to pay for the environmental damages. But Occidental emphasises proper assessment of envi-

ronmental damages first" say-ing that the Tk 600 crore claim

was not made on the basis of a "proper yardstick". "Besides,

According to the present as-sessment, Occidental should pay Tk 10 crore in the first year for the physical damages done in Magurchhara. In the next 50 years, the American company must pay Tk 12 crore annually to fully restore the environment, the sources said.

Experts from both the sides are expected to meet soon to settle this issue. Meanwhile, Occidental's work in these blocks are suffer-

ing heavily because of the delay in extension of the PSC. The draft of the extended PSC says that when approved, it would be effective retrospectively from January 11, 1998. Like the original PSC, the ex-tension would be for three years. "Therefore Occidental has already lost valuable time in progressing its work there,"

said a source.

Occidental's PSC for these two blocks expired in January Il last because of the company's failure to fulfil the "minimum See Page 12 Col 4
