

#### British-Bangla Law Week begins today

The "British-Bangla Law Week" marking the 50th anniversary of the Declaration of Human Rights begins in the city today, reports UNB.

Some high profile judges, lawyers and academics of England and Dhaka will give talks on current human rights issues, said a press release.

The aim of the week is to give the attending para-legal, lawyers, judges, NGOs, and government officials and academics an opportunity to review, among other things, the improvement to governance at the legal and judicial level and effective enforcement of human

rights by the Bangladesh court. A comparison will also be made between the human rights enshrined in the Bangladesh constitution and the human rights treaties.

Besides, an insight will be given into how the international treaties are presently being applied to alleviate the plight of the Bengali people.

A comparative analysis of the regional variations of human rights law will also be discussed.

A mock trial will also be held to demonstrate how the English court works.

## Five arrested with firearms

Five alleged criminals were arrested with nine firearms, 19 bullets and explosives in separate incidents in the city yesterday.

The arrested were identified as Mizanur Rahman, 24, Rezaul Huq, 22, Rabiul, 25, Nurul Huq and Kamruzzaman.

Acting on a tip-off, police raided a studio at Kadamtala, under Sabujbagh thana and arrested Mizan and Rezaul. Two foreign made revolvers with bullets were recovered from their possession. Police suspected that they are members of a criminal gang.

Lalbagh police arrested Rabiul with one foreign-made revolver and two pistols from near Bakshibazar while he was traveling in a autorickshaw.

Nurul was arrested from a residence at Mirpur. Police also recovered one Sawn-off rifle two foreign-made revolvers, one LG along and 16 bullets from a toilet of the house.

Acting on the statement of Nurul Huq, police also arrested Kamruzzaman and seized huge quantity of explosive materials from another house under Mirpur thana.

On November 29, 1971, Pakistani occupation forces raided 14 villages under Baktabali union in Fatulla thana here and brutally killed 139 freedom fighters.

The occupation forces, on information from their local collaborators, attacked Baktabali regional training centre of the Muktibahini and set fire to all the houses in the area.

In observance of the day, former students of Kanainagar Sobhania High School will hold a memorial meeting at its

Local people demanded that a memorial to the 139 martyrs be erected soon.

### BNP protests arrest of Helal
