### Final Notice to Join Duty

Research Assistant working at INST Tromd of Atomic Energy Research Establishment of the Commission at Savar Mr Md Abdullah-Al Mamun, S/o Late Md Wasek, Vill-Biramkandi, PO-Karikandi, PS-Daudkandi, Dist-Comilla was granted 2 (two) years lien from 3-3-94 to 2-3-96 vide Commission's Memo No Estb-2-7(83)/91 dated 19-8-95 from Commission's service for foreign (Saudi Arabia) service. He did not join his own place of work in spite of expiry of limit of the lien on 3-3-96. Later on he was asked for explanation & instructed to join duty vide Memo No. Estb 6(20)/CAD-95 dated 7-5-96. It may be noted that he has been absent from place of work for additional 2 (two) years 9 (nine) months after expiry of his lien period of 2 (two) years from 3-3-94 to 2-3-96, that is continuously (4 years 9 months) from 3-3-94 till date.

Whereas his such conduct is detrimental to office discipline and punitive offence as per BAEC Service Rules 1985.

Whereas in spite of issuing complaint against him for "negligence of duty" & "misconduct" described under clause 57 (2) & (3) of BAEC Service Rules 1985 vide Commission's Memo No. even dated 28-6-98 he did not give any reply within the prescribed time limit nor took opportunity of self defence.

Therefore, he is being issued show cause notice as per clause 60(4) of the Service Rules to explain why he should not be dismissed from service as an opportunity for self defence prior to dismissing him from service according to provision described under clause 58(1) (G) of BAEC Service Rules 1985 for the above mentioned offence. Written reply should reach this office within 10 (ten) days of publication of this notice in newspaper. Otherwise the Commission's unilateral decision will turn to be final.
