'Munajatuddin's reporting will always inspire newsmen'

Speakers at a discussion meeting yesterday recalled the contribution of late journalist Munajatuddin and said that he had established rare values in the society through his in-depth reporting.

Besides highlighting various problems of rural Bangla, they said, Munajatuddin tried to project positive image of the villages and his reporting will always inspire the newsmen who are working outside the capital city.

Journalist Munajatuddin Smriti Sangsad organised the discussion meeting at the Jatiya Press Club, which was followed by distribution of Munajatuddin Smriti Award '97. Former Chief Advisor of the caretaker government Justice Muhammad Habibur Rahman addressed the function as chief guest.

Southern region's correspondent of daily Bhorer Kagoj Fakhr Alam has been awarded Munajatuddin Smriti Puraskar for his series of investigating reporting for the year 1997. He was given a crest, a certificate and a cheque for Tk 25,000 as prize money.

Presided over by journalist Santosh Gupta, the discussion was addressed by Prof Sirajul Islam Chowdhury, BFUJ president Iqbal Sobhan Chowdhury, The Daily Star Editor Mahfuz Anam, Acting Editor of Sangbad Bazur Rahman, Dr Golam Rahman, journalists Hedayet Hossain Morshed, A T M Shamsuddin and dramatist Mamunur Rashid.

The speakers said that the late journalist projected such vital issues of rural areas which had never appeared in newspapers in the past. His writings greatly helped the rural people who were neglected for decades, they added.

Speaking on the occasion, Justice Habibur Rahman stressed the need for maintaining neutrality in newspaper for the greater interest of its owner as well as for the paper itself. There is no alternative to maintaining neutrality of newspaper, he further said.

Recalling the contribution of late Munajatuddin, Justice Habibur Rahman said the reporting of Munajatuddin is an example for the journalists and his writings will be remembered in the history of journalism in Bangladesh.

Prof Sirajul Islam Chowdhury said that despite various obstacles Munajatuddin never compromised with authenticity. In the struggle of justice against injustice, he said, Munajatuddin took the side of justice and fought for establishing justice through his reporting.
