

Garment workers demand payment of arrears

Garment Workers-Employees Action Council has demanded payment of all outstanding salaries and festival bonus before the Eid-ul-Fitr.

The demand was made at a meeting of the council held yesterday with its coordinator Sirajul Islam Rony in the chair. The meeting urged the garment owners to pay the outstanding salaries by the 15th of Ramadan and festival bonus by the 20th of Ramadan.

It strongly condemned the attacks on the workers who were demonstrating for realising their demands in different garment factories recently.

The meeting was addressed by Shafiuddin Ahmed, Kamrul Ahsan, Shafiqur Rahman Mollah, Delwar Hossain and Imdadul Haq Masud.

Meanwhile, garment workers' leaders of 10 organisations in a joint statement yesterday condemned the attack on the workers of Purple Garments at Elephant Road, in which at least 50 workers were injured.

They blamed the owner of the factory for the attack and demanded punishment of those responsible for the attack. The leaders also demanded release of arrested workers and withdrawal of cases filed by the owners.

Nirmul body to observe Hatred Day today

The Nirmul Committee has been observing the December 29 as "Hatred Day" since Golam Azam was made Amier of Jamaat-e-Islami on this day in 1991.

The Nirmul Committee will hold a rally at Central Shaheed Minar at 3 pm today which will be followed by burning of an effigy of Golam Azam.

Justice KM Subhan, poet Shamsur Rahman, Syed Shamsul Haq, Prof Borhanuddin Khan Jahangir, journalist Kamal Lohani and Panna Kaisar, MP, will address the rally.

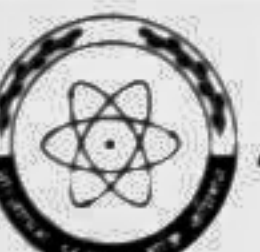

Notice

Subject: Implementation of Nuclear Safety and Radiation Control Act-1993 (Act No. 21 of 1993).

The "Nuclear Safety and Radiation Control Rules-1997 (SRO No. 205-Law/97)" formulated by the Bangladesh Atomic Energy Commission vide Section 16 of the Nuclear Safety and Radiation Control Act-1993 (Act No. 21 of 1993) was published in the Bangladesh Gazette on 18th September, 1997 and was put to force from the same date.

It is mandatory by Section 4 of the Act for all persons involved in using, procurement, owning, storing, transporting of radioactive materials, nuclear materials and devices (including X-ray Machine) capable of producing ionizing radiation to take licence in prescribed manner from the Bangladesh Atomic Energy Commission. Failure to take licence or non-compliance with any of the provisions of the rules are considered as offence and are subject to penalty vide Section 11 of the said Act.

It may be mentioned that those persons, involved in the said practices, who have not yet taken licence from the Bangladesh Atomic Energy Commission are already subject to penalty vide Rule 8.2. But Bangladesh Atomic Energy Commission considering the fact that many of the users are ignorant about the legal requirements and that the requirements are stringent has extended the date of reporting to the Bangladesh Atomic Energy Commission till 30th June, 1999 and for taking licence till 31st December, 1999.

The procedures of taking the licence are rigorous and based on stringent scientific and technological analyses and assessments and a Radiation Control Officer (RCO) for those practices is mandatory. It is, therefore, in the interest of the persons concerned that they should immediately contact the undersigned and apply for necessary licence to avoid legal penalty.

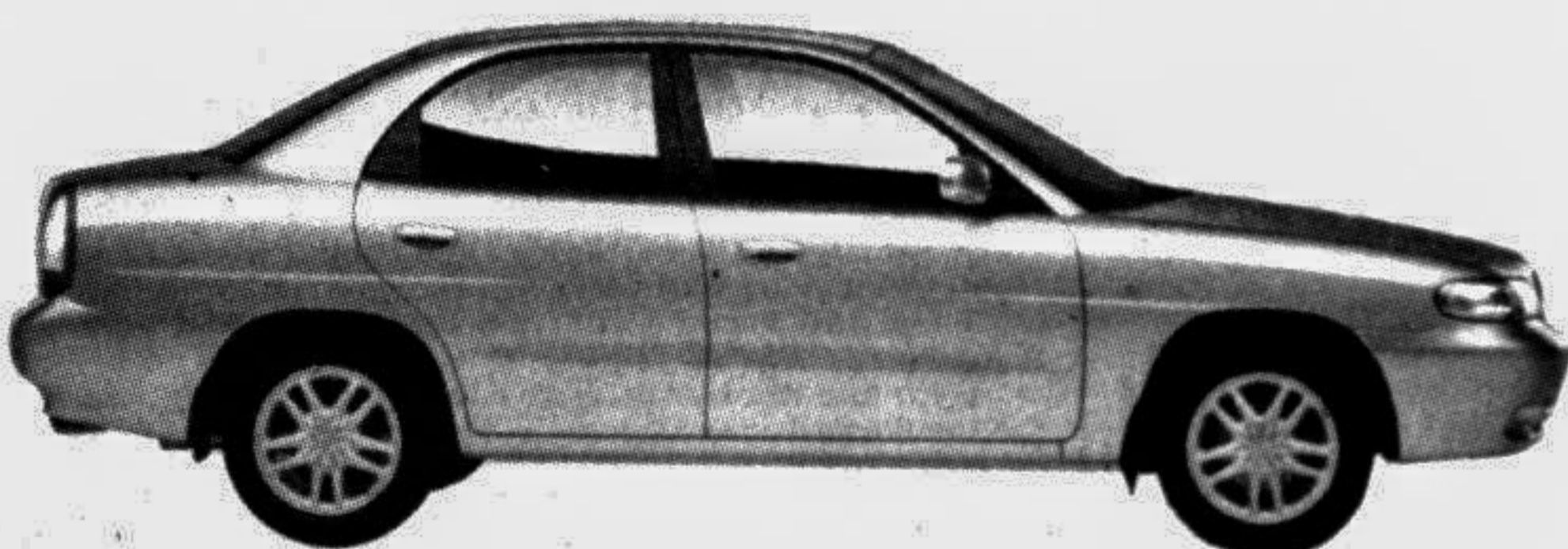
