Bus helper killed on Dhaka-Aricha highway

MANIKGANJ, Jan 8: A bus helper was killed and another seriously injured in a road accident on the Dhaka-Aricha highway at Barongail in Shibhalaya thana on Thursday, reports APB.

Police said the mishap occurred Thursday morning when an Aricha-bound bus tried to overtake a standing bus at Barongail Bus Stand, killing Belal, 35, the helper of Jatrishiba Paribahan, on the spot.

Another report says: An old man allegedly committed suicide following a family feud in Shibhalaya Sadar on Wednesday night.

Police said the body of Nishan, 70, was found hanging by a rope with a tree near their residence.
