



Kafco continues to cause clamour

Dubbed the Deal of the Year in 1990, later fabled as Bangladesh's first flagship investment, the crisis-ridden Kafco is continuing to confront prob-

The latest is a controversy regarding the acceptance of the plant from its general contractors, who, amazingly, are also the shareholders of the US\$ 600 million ammonia-urea fertiliser company.

The plant should have been handed over to and accepted by the company more than four years ago but, as a Kafco document has it, "numerous technical problems" and low-quality equipment forced a series of shutdowns before a required performance test.

The closures caused huge financial losses for the company, estimated to be more than USS 120 million. The contractors were insisting on a settlement that would give Kafco only US\$ 16 million in cash, with no option to ask for compensation in future.

The controversy deepened after one of the company's former chief executives had come

up with a strong plea for the Bangladesh government, the largest shareholder, not to accept the plant.

The Plant Acceptance, hence at the core of the current round of high conflicts between the shareholders and the contractors, will now depend more on the government. The Board of Directors, in its

latest meeting on January 25, left the issue unresolved while trying to deal with "financial restructuring" of a company languishing in deep debts. The debts are mostly guaran-

teed by the government of Bangladesh. Kafco began with more than US\$400 million in liabilities with various lenders and is still burdened with "just over US\$ 300 million" loans, roughly two-thirds of which are in the Japanese currency.

The entire amount of export credit was guaranteed by the government after a lot of wrangling with its foreign partners. Today, more than US\$ 190 million - including some 15-16 million in suppliers' credit. still forms the part of the loans secured with the government

everything, he reasons. In 1998, the company made as much as "US\$ 21 million less than what we would have earned" compared to the situation during 1986-97, according to estimates by Fateh. "This loss of profit is enormous for a company with US\$ 120 million net equity."

SC orders PM's reply in two weeks By Special Correspondent .

The Appellate Division of the Supreme Court yesterday passed an order asking for a statement from the prime minister within two weeks concerning her alleged remarks on granting bails to 1200 people by the High Court Division in two days in August last year. "We want signed statement

from the Honourable Prime Minister with regard to the said alleged statements which will be supplied to us by the learned Attorney General to be submitted within two weeks from the date. The matter is adjourned till 17.2.1999," the brief order

The order was passed after hearing on a contempt petition filed by the President of the Supreme Court Bar Association against the Prime Minister.

The full bench of the Appellate Division headed by Chief Justice A.T.M. Afzal heard Bar President Habibul Islam Bhuiyan who moved the petition on Monday and Attorney General Mahmudul Islam before passing the order.

"Heard the applicant Mr Habibul Islam Bhuiyan, President, Supreme Court bar Association, and the learned Attorney general. Perused the application for drawing up the con-

tempt 'proceeding against Sheikh Hasina Wazed, the Honourable Prime Minister of Bangladesh. Our attention has been brought on certain statements of the Prime Minister published in Daily Dinkal and Sangram on 30.1.99 relating to granting of bail by the High Court Division and remarks on the Hon'ble Chief Justice. The relevant portions of the report have been marked by us and brought to attention of the learned Attorney General. We want signed statement from the Honourable Prime Minister with regard to the said alleged statements which will be supplied to us by the learned Attorney General to be submitted within two weeks from the date. The matter is adjourned".

This was the first time that a contempt petition had been moved against an incumbent prime minister of Bangladesh. A large number of lawyers and people crowded the court to hear the arguments of the two sides yesterday morning. Bhuiyan, a member of the

Code of Civil Procedure Bill placed in JS for reconsideration

The Code of Civil Procedure (Amendment) Bill, 1998, was tabled in Parliament yesterday for reconsideration, report

Passed in the last session of Parliament, the Bill was sent to the President for his assent. But he returned it to the House asking for reconsideration of certain provisions.

Speaker Humayun Rashid Chowdhury tabled the bill under rule 97 of the Rules of Procedure.

Laying the bill on the table of the House, Speaker Humayun Rasheed Chowdhury said the bill, passed by the House on November 10 last year, was sent back by the President for reconsideration on December 6 last with a message. But, he said, as the House was not in session,

the message of the President was published on December 8 in a special bulletin.

After laying of the President's message along with the Bill, Shamsul Islam of BNP told the Speaker that the Opposition had not received the bulletin till now.

The House had passed the Code of Civil Procedure (Amendment) Bill reempowering the district and the additional district judges the jurisdiction for revision of the civil suits and proceedings decided

by any subordinate courts. The Bill, as passed by the House, was sent to the President

for his assent on November 20. President Shahabuddin, in his message, said the revisional power could be given to only the See page 11
