BFUJ, DUJ condemn attack on journalists

Leaders of Bangladesh Federal Union of Journalists (BFUJ) and Dhaka Union of Journalists (DUJ) yesterday strongly condemned the attack on journalists by terrorists and police and damaging of newspaper vehicles during the opposition-sponsored 66-hour hartal, reports BSS.

In a joint statement, Abul Kalam Azad and Akhtar Ahmed Khan, president and secretary general respectively of BFUJ, and Shuvo Rahman and Azizul Islam Bhuiyan, acting president and general secretary respectively of DUJ, urged all concerned to refrain from carrying out such heinous acts.

DRU, BPJA

Dhaka Reporters' Unity (DRU) yesterday expressed grave concern over the incidents of attacks on reporters during hartal hours in the last two days.

DRU president Shahjahan Sardar and general secretary Mohidul Islam Raju in a statement said although the vehicles carrying journalists have been kept out of the purview of the hartal, such vehicles are being attacked frequently.

"It has been difficult for journalists to discharge professional responsibilities due to the attacks and their lives are now at stake," the statement said, calling upon all concerned to refrain from attacks or repressive acts on journalists during political programmes including hartals.

In another statement, Bangladesh Photo Journalists' Association (BPJA) also strongly protested and condemned the attacks on photo journalists during hartal hours yesterday.

Demanding punishment to the persons involved, BPJA called upon the political parties and the Police to extend cooperation to the photo journalists in discharging their duties.

"Some unruly political activists beat up photo journalist of the Janakantha Abdus Samad Jewel and snatched his camera near Jatrabari crossing yesterday morning. Photo journalist of the Sangbad Sohrab Alam was also man-handled" the statement said.

In another incident, photo journalists Amran Hossain, Mir Ahmed Miru, Mamun Abedin, Masud Parvez Milon and Hasanuzzaman Taron of The Daily Star, Manabjabin, Bhorer Kagoj and Janakantha respectively were injured when police swooped on them without any provocation and beat them up indiscriminately, it added.

Her qulhwani will be held on Feb 28 at the Mohammadpur residence of Lutfa Taher, widow of Col Abu Taher.

Death anniversary

Today is the 26th death anniversary of Abdur Rob (Boga Mia), ex-Member of Parliament, freedom fighter and President of the Pabna District Awami League. He was the first to hoist the flag of Bangladesh in Pabna district during Liberation War in 1971, says a press release.

Abdur Rob died in a tragic car accident on February 25 in 1973.
