The government assured all possible treatment for the injured victims of the hartal violence as several ministers yesterday visited them in hospitals, reports BSS.  
They inquired about the condition of rickshaw-puller Shukkur Ali and others and instructed the hospital authorities to provide them with the best possible treatment.  
The right arm of Shukkur Ali, 45, had to be amputated after it was blown off by a hand made bomb hurled from a minibus in front of the Press Club yesterday.  
Health Minister Salahuddin Yusuf assured him of allout support from the government following his recovery.  
Another rickshaw-puller, Mohammad Monir, is also undergoing treatment in the hospital after hartal activists hurled a bomb at him while he was playing his rickshaw at Khilgaon area.  
"What kind of politics is this which claims the livelihood of the poor... how can they expect votes from us after injuring my husband" the young wife of Monir asked.  
Home Minister Rafiqul Islam, Bir Uttam, Works Minister Mohammad Nasim, Law Minister Abdul Matin Khasru and State Minister for Jute AK Faezul Haq also visited the injured and enquired about their conditions and treatment.

**Dr Garst calls on Hasina**  
Eminent orthopaedic surgeon Dr Garst called on Prime Minister Sheikh Hasina at her office yesterday, reports BSS.  
During the meeting, the Prime Minister recalled his services and contributions with appreciation in Bangladesh.  
Dr Garst, who worked in Bangladesh for a long time, has treated many injured freedom fighters after the country's independence in 1971. He has also great contribution in setting up of the Rehabilitation Institute Hospital for the disabled in Dhaka.  
The government has given honorary citizenship of Bangladesh to Dr Garst for his outstanding contribution in the field of medical service.  
Mrs Garst accompanied her husband during the meeting.  
Among others, Health and Family Welfare Minister Salahuddin Yusuf was present on the occasion.

**Nasim expresses surprise over FEMA report**  
Post, Telecommunications, Housing and Works Minister Mohammad Nasim yesterday expressed surprise over two newspaper reports containing comments on an election monitoring agency on Pabna by-election and the just concluded pourasabha elections, reports BSS.  
One of the reports quoting the agency, FEMA, said the polling were not held properly at Shujanagar centre of Pabna. Another report quoting the same agency yesterday said there would be an understanding on the pourasabha polls.

In a statement, the minister said, "the observation of the agency on voting of a centre after three months has surprised us." He said "it is not clear to us why and to serve whose purpose, FEMA is now questioning the transparency of Pabna by-election, the fairness of which has been acclaimed by observers and journalists from home and abroad."

He also rejected the idea of any understanding on the results of the poura polls and termed the speculation as ridiculous.
