The fire originated from a short circuit and raged for about two hours before fire fighters extinguished the flames. Property worth about Tk 10 lakh were also gutted, locals claimed.

Fire service men had difficulties to control the blaze due to shortage of water in the area. In the meantime some agitated people attacked the fire fighters, injuring some of them and damaging a fire service vehicle.
