MYMENSINGH, Apr 4: Death toll in Friday's train accident here rose to two with one more death yesterday, reports UNB.

A man was killed and about 200 were injured when the Chittagong Mail train derailed at Shuhagpur station here.

Seriously injured Jalaluddin (25) died at the Mymensingh Medical College Hospital at 6 am yesterday.

Meanwhile, 50 of the 86 injured in the accident admitted to the Mymensingh Medical College Hospital were released after treatment.
