BNP, allies stage demonstrations in city today

Jammat-e-Islami Bangladesh will hold a protest rally at Purana Paltan crossing at 5 pm while Islamic Oikya Jote will hold its rally at Purana Paltan Mosque area in the

afternoon. Meanwhile, Dhaka city BNP convenor Sadek Hossain Khoka in a press statement has urged the party leaders and workers, and city dwellers to join today's procession.

Opposition's mass procession now on May 3

Manju warns Ershad

Stop behaving like a military dictator

The Jatiya Party (JP) vesterday formally split with a special council led by former prime minister Mizanur Rahman Chowdhury and Anwar Hossain Manju supported by 14 of the 33 party legislators, report agencies

The council attended by several thousand JP representatives from across the country distanced themselves from the party's founder, former president Hussain Muhammad Ershad, alleging that he was still behaving like a military

"If you (Ershad) still believe that you can continue to behave like a military dictator unopposed, I would like to warn you. We enjoy far more strength than you have," an angry Anwar Hossain Manju told the two-day rally at the Paltan Maidan.

He alleged that the former

president always took decisions in an autocratic manner and now he sided with Khaleda Zia to "save the property, which he grabbed illegally while in

power." In a veiled reference to the opposition movement, he told the delegates and representatives that a quarter is active to change government in an undemocratic way. "Conspiracy is going on to seize power without ballot."

Pointing his finger to the Khaleda-Ershad alliance. Manju said: "You (Ershad) go to Hasina for release and to Khaleda Zia for protecting plundered wealth ... we don't do politics of protecting looted

Manju said politicians in the name of improving the fate of the people and the country indulged in making their own

fortune by plundering national wealth. "They should be punished ... corruption spread as the corrupt were not brought to

Referring to a World Bank report on Bangladesh, the Communications Minister rejected it saying that the report did not mention the corruption of ministers, MPs, and presidents. "Report that makes mention of only corruption of policemen or small thieves is not acceptable."

Referring to a statement of Ershad that Manju is not a factor, he said it would be proved in the next election.

The council of the faction came a week after Ershad staged the party's first council since he floated it while in power in

Khagrachhari tense: Sec 144 at 5 places

From Our Correspondent KHAGRACHHARI, Apr 23: The district administration today imposed Section 144 at five places in the town following yesterday's clash between police and tribesmen.

The places where Section 144 has been imposed are stadium, Swanirvar, Changi Square, bus station and Zero Point areas.

At least two activists of Pahari Gano Parishad were killed and 150 others injured when police opened fire to disperse the supporters of the organisation who tried to hold a rally at Khagrachhari stadium defying ban.

Earlier, Gano Parishad, an organisation of tribesmen opposing the CHT Peace Accord convened a rally at the stadium demanding full autonomy of the Chittagong Hill Tracts.

The ban on holding rallies at the stadium was imposed by the district administration as another group supporting the peace accord convened a rally at the same venue the same time. See Page 12 Col 2

Fire shuts repaired Khulna power plant during trial run

Khulna, April 23: A 110 MW unit of Khulna Power Station (KPS) at Goalpara has been closed as it caught fire during trial operation after overhaul-

Boilers of the plant caught file soon after taking 'load' at about 8 pm Thursday. Repair of the fire-damaged equipment was not started till this evening.

Golam Mostafa, Chief Engineer of KPS, said the fire was an accident and the plant "requires a thorough checking and rechecking to see if it is fully serviceable right at this moment".

The damage caused by the fire is yet to be ascertained but an engineer of the plant referring anonymity told The Daily Star that it would be worth over one crore taka. Fire Brigade units from Khalishpur and Daulatpur put out the fire in about two hours, sources at the plant said.

The plant was overhauled by two Chinese firms--NEIE and GIETC -- at a cost of Tk 15 crore, the work beginning in January. The overhauling which involved some major repair work was scheduled to be completed by March 31.

Sources in the PDB here claimed that before the fire incident, the plant's trial operation had stopped twice on Thursday without power generation because of major mechanical faults that developed allegedly due to use of "substandard meterials" in the overhauling. "The Chinese contractors were compelled by the PDB appointed consultants to use substandard materials", he claimed.

Arif had close relations with MP Manik, brother claims

From Staff Correspondent SYLHET, Apr 23: The elder brother of Arif Haider, who was killed in a bomb blast at the house of ruling party MP Muhibur Rahman Manik, has said Arif had close relations with the MP, Babul (killed in the same incident) and Gopal, Juba League activist who is missing since the blast.

Arif's relation with Manik is well known to the people of my area as well as of Chhatak, said Khokan Haider while talking to this correspondent

Though the MP is not acknowledging the relations with my brother now, there are lot evidences that, the MP even visited our house in the Madina Market area several occasions. Manik and his associates

are responsible for the death of my brother, alleged Khokan, They do not even ask anything about the family now. Rather. some influential people are now threatening us not to talk about these things openly, said Arif's elder brother.

Arif was well known to Manik before the Awami League came to power. He was introduced to Manik by Ward Commissioner and Sylhet District Juba League Joint Convenor Ja-See Page 12 Col 2

Chhatak BNP's 3-day programme demanding arrest of Manik

The programmes were announced at a press conference at Sylhet Press Club this afternoon. Former MP Kolimuddin Milon, Central Vice-President of JCD Mizanur Rahman Chowdhury Mizan and President and Secretaries of Chhatak and Doarabazar thana units of BNP and its front or-

ganisations were present. The leaders alleged that after the search of the Army team of explosive experts and press re-

ports, it was clear that the MP's house was a weapons factory. But, the government neither took action against the MP nor any of his associates, they said.

Five killed in Tangail truck plunge

TANGAIL, Apr 23: Five peo-ple were killed and 15 others injured today when a truck skidded off Dhaka-Tangail highway and plunged into the roadside ditch at Karatipara, 9 km off the town, reports UNB.

Police said the accident took place when the driver of the cement-laden Tangail-bound truck from Dhaka lost control over the vehicle leaving five people killed on the spot.

Three of the dead were identified as Saiful Islam 20, Bablu Mia 25, and Feroj Mia 22 of Kalihati thana while the identity of two others could not be

known. Of the injured, 13 were rushed to Tangail General Hos-

VGD helps the hardcore poor women in rural areas

Poor women in rural Bangladesh are now looking at life in a different way, thanks to vulnerable group development (VGD) programme, the world's largest poverty alleviation ven-ture. The hard-core poor women in the rural areas have enrolled themselves in various incomegenerating activities.

Geographical diversity makes no difference to Asma of Tangail or Suravi of Bogra. They have found a new meaning

At village Boalzan in Delduar thana of Tangail, Asma runs Supanya, a grocery shop she owned a year ago with credit from BRAC while undergoing a training under the VGD programme. Her husband is having problems with his eyesight.

Asma's neighbour, Monwara, who used to live on wheat given under the VGD programme barely three years back, now rears chicks at her courtyard and earns Tk 1,000 a month. She got trained in chick rearing at BRAC under the VGD programme. Monwara's husband is now jobless after his handlooms fell prey to a price crash a few months back.

The World Food Programme provides wheat for the VGD programme while BRAC comes up with the training and credits to the vulnerable ones. But despite the good job by the two organi-sations, beneficiaries say to a group of visiting newsmen that a 15 per cent interest against any credit is too much for them. They do not like the system of starting the recovery process within 15 days of granting loan,
