FEMA for appointment of female CEC
Fair Election Monitoring Alliance (FEMA), Study and Research Group (SRG) of MSS and Women for Women jointly organized a consultation meeting with the Women Leaders on Electoral Law Reform on Saturday at 4 pm at the WVA auditorium, says a press release.
Women leaders proposed that women may be appointed Chief Election Commission. The participants further proposed that reserve seats for women should be increased from 30 to 100 with provisions for direct election to the parliament.
The meeting was presided over by Salma Khan, Chairperson Women for Women amongst other Tasmina Hossain (MF), Dr Nazma Chowdhury, Prof Dilara Chowdhury, Dr Hamida Khandoker, Rokeya Ahmed, Maleka Begum, Feroz M Hassan, Secretary General of FEMA, Vice Chairpersons Munira Khan and Ataur Rahman, Advocate Salma Ali, Joint Secretary and Tarikul Ghani, Executive Director, FEMA, were present in the meeting.
Women leaders in the meeting suggested that to empowerment of women it is necessary to ensure state funding to allow women candidates to contest election. They also suggested that after the end of two terms of the present parliament, law should be enacted making it mandatory of each political party to nominate 30% of its total candidate from amongst women. Women leaders also opined that a candidate shall be entitled to contest parliament seat if only his or her name appears in the voter list.
FEMA's recommendation regarding empowering the EC appointment of officers of EC or members of the civil society as Returning Officer instead of DC, enrollment of floating population and Bangladeshi citizen leaving abroad as voter, compulsory issue of voter ID card, control of election expenses.
