PM urges Imams to lead society towards peace

Prime Minister Sheikh Hasina yesterday said her government would build a peaceful society following the tenets of Islam where all faiths, economic and social activities will go on in concurrence uninterrupted, reports UNB.

"Islam is a religion of peace which never allows anarchy, terrorism, addiction or environmental pollution," she said addressing the national conference of Trained Imams at Osmani Memorial Hall in the afternoon.

Hasina called upon the Imams to lead society towards peace and tranquillity by preaching the teachings of Islam and help build a developed nation.

She said some times Islam is misinterpreted and innocent rural people, particularly women, fall victim to such misinterpretations. "They are subjected to repression through fatwa".

The Prime Minister asked the Imams to play their due role to stop these types of misinterpretation of the religion to save the rural, ignorant women. She also urged them to play due role against the dowry system saying that "we do not expect more deaths of women for dowry".

Trained Imams from all over the country joined the function where best three of them at national level and 21 from division and regional levels were awarded with crest, cash and citations.

Hasina said Imams are respected personalities of society. People follow their advice, she said calling upon the Imams to involve themselves with socio-economic development efforts alongside playing their religious roles.

She said the trained Imams would guide the people in different matters and advise them about family welfare, resistance of contagious diseases, taking pure drinking water, using sanitary latrine, and about cleanliness, and farming.

"We want to make the trained Imams into the catalysts for development," she added. The government has so far trained over 40,000 Imams of the country on various social issues.

The Prime Minister said the government was working as per Islamic tenets and would also continue its all out efforts for the cause of Islam. She mentioned various steps of the government in this regard.
