### BNP MP's writ HC order stayed

The Supreme Court yesterday stayed operation of a verdict of the High Court that discharged the rule in a writ petition challenging maintainability of an election petition pending before the Divisional Election Tribunal against BNP MP Mahbubur Rahman, reports UNB.

The order of stay for 4 weeks was passed by the chamber judge, Justice Bimalendu Bikash Roy Chowdhury, and asked the petitioner for filing the regular leave petition for hearing by the full court.

Mahmudur Rahman Belayet of Awami League who was defeated in the election filed the election petition before the Divisional Election Tribunal challenging election of Mahbubur Rahman.

Against the move of Belayet, Mahbubur Rahman had filed a writ in the High Court which was discharged on May 16. The Court also ordered that Tk 10,000 be paid by the writ petitioner Mahbubur Rahman.
