AN ELEGY AND AN APPEAL IN ADVANCE

Dear Friends

You are certainly aware that the government has finalised its decision to construct an International Summit Centre at Osmani Uddyan in the Gulistan area of Dhaka. The foundation stone has already been laid for this centre consisting of 5 thousand seats for ensuing NAM (Non Align Movement) summit to be hosted by Bangladesh in the year 2001. Indeed this particular place which has been selected contains 11 thousand trees as per government's statistics. So if the government is to implement its decision for constructing the said summit centre it will have to fell the trees of Uddyan.

These activities of cutting thousands of trees will obviously be an incredible and too disastrous incident. Dhaka has already been denoted as world's top most polluted city. Thereby as the fatality of consequence of cutting thousands of trees the present environmental condition of Dhaka will be worsened to a colossal stage. Since the city has already been gone nearest to become claustrophobic for city dwellers to breathe, the cutting of a huge number of trees at Osmani Uddyan will just strangulate the helpless people of Dhaka city. We have all the good reasons to apprehend that if this attempt to cut trees at Osmani Uddyan is successful, other Uddyans too will be attacked in the same atrocious way. We must work unitedly to stop this decision from being implemented. If we fail we shall have to bear the high risk of our failure for all the decades to come. The future generations will definitely want to know, were there no conscientious person living at that time while thousands of trees were cut? Did they not react even minimally to such an incident?

We will be relieved and happy if the authority changes its decision to construct the summit centre in some suitable place other than the Osmani Uddyan on considering its catastrophic effects on the environment of Dhaka city which has already become uninhabitable, environmentally speaking. Despite the overwhelming condemnation from the people belonging to all strata of life if the government still remains obstinate in its decision to fell trees at the Osmani Uddyan, it will be really a ludicrous and hypocritical for the government to observe the World Environment Day on June 5th. Indeed keeping this auspicious day ahead it is our clarion call and earnest appeal to all the Environment Scientists at home and abroad to join us in our solemn struggle to persuade the government to change its selection of place for the construction of said summit centre and thereby the government should announce its changed decision anyhow before June the 5th.

I hereby pay my heartiest respect to those conscientious persons of the country who have raised their voices to restrain the government from committing atrocities to the environment of Dhaka city. And I wish their stretched and united hands be successful in pressing home their rightful civic demands. Also I sincerely appeal to the pro-liberation forces of the country who acknowledge the contributions of M. A. G. Osmani in our liberation war to protest against this action which will not only be environmentally disastrous but will also constitute an insult to the memory of the Commander-in-Chief of the liberation war of 1971.
